

#### 1 Definitions

Unless the contrary intention is expressed, all defined terms in the Senior Facility Agreement shall have the same meaning in this Standard Security and

Event of Default means each of a Senior Event of Default or a Mezzanine Event of Default

Finance Document means each of a Senior Finance Document and any Mezzanine Finance Document

Finance Party means each of a Senior Finance Party and the Mezzanine Bank

Intercreditor Agreement means an intercreditor agreement dated on or about the date of this Standard Security between, amongst others, the Common Security Trustee (1), the Senior Agent (2), the Senior Borrower (3) and the Mezzanine Purchaser (4) and any agreement entered into under or supplemental to it or amending, restating or novating it

Liabilities means all monies, obligations and liabilities which shall from time to time (and whether on or at any time after any demand or judgment) be due, owing or incurred from each Obligor to the Finance Parties under the Finance Documents whether actually or contingently and whether solely or jointly with any other person and in whatever style or name and whether as principal or surety

Mezzanine Bank means any entity which accedes or has acceded to the Intercreditor Agreement as an "Original Mezzanine Bank" (as such term is defined in the Intercreditor Agreement) and/or any other entity to which such Original Mezzanine Bank assigns or transfers or has assigned or transferred any of its rights and/or obligations under any Mezzanine Facility Agreement and the Intercreditor Agreement in accordance with the provisions of the Intercreditor Agreement

**Mezzanine Event of Default** means an "Event of Default" under and as defined in any Mezzanine Facility Agreement

Mezzanine Facility Agreement means a murabaha facility agreement entered into or to be entered into between the Mezzanine Bank (1) and the Mezzanine Purchaser (2) in accordance with the terms of the Intercreditor Agreement and any agreement entered into under or supplemental to it or amending, restating or novating it

Mezzanine Finance Document means a 'Finance Document' under and as defined in any Mezzanine Facility Agreement

**Mezzanine Obligor** means a "Mezzanine Obligor" under and as defined in any Mezzanine Facility Agreement

Mezzanine Purchaser means Ability Hotels (IV) Holdings Limited, a limited company incorporated in England and Wales with registration number 09333595 whose registered office is at Top Floor Hampton by Hilton, 42-50 Kimpton Road, Luton, Bedfordshire, United Kingdom LU2 0NB

Obligor means each of a Senior Obligor and any Mezzanine Obligor

Security Subjects means a standard security granted by Sydney & Ballater Properties Limited in favour of Townside Limited dated 11 March 2005 and registered in the Land Register of Scotland under Title Number GLA144640 on 7 April 2005 and assigned to the Chargor by an assignation by Townside Limited dated 17 October 2007 and registered in the Land Register of Scotland under Title Number GLA144640 on 24 October 2007 over ALL and WHOLE that plot or area of ground extending to 0 759 hectares or thereby and registered in the Land Register of Scotland under Title Number GLA144640

Senior Agent means the "Agent" under and as defined in the Senior Facility Agreement

Senior Borrower means Ability Hotels (IV) Finance Limited a limited company incorporated in England and Wales with registration number 09333622 whose registered office is at Top Floor, Hampton by Hilton, 42-50 Kimpton Road, Luton, Bedfordshire, LU2 0NB, England

Senior Event of Default means an "Event of Default" under and as defined in the Senior Facility Agreement

Senior Facility Agreement means a facility agreement dated on or about the date of this Standard Security and made between, amongst others, the Senior Agent (1) and the Senior Borrower (2) and any agreement entered into under or supplemental to it or amending, restating or novating it

Senior Finance Document means a "Finance Document" under and as defined in the Senior Facility Agreement

Senior Finance Party means a "Finance Party" under and as defined in the Senior Facility Agreement

Senior Obligor means an "Obligor" under and as defined in the Senior Facility Agreement

#### 2 Interpretation

- 2.1 Unless otherwise indicated any reference in this Standard Security to
  - (a) a "person" includes any individual, firm, company, corporation, government, state or agency of a state or any association, trust, joint venture, consortium or partnership (in each case whether or not having separate legal personality).
  - (b) any person shall include that persons successor in title, permitted assignees or assigns or permitted transferees and in the case of the Common Security Trustee, shall include such other person as may from time to time be appointed as Common Security Trustee for the Finance Parties.
  - a provision of law is a reference to that provision as extended, applied, amended or reenacted and includes any subordinate legislation,
  - (e) words denoting the singular shall include the plural and vice versa and words denoting any gender shall include all genders,
  - (f) a clause heading is a reference to a clause or sub-clause of this Standard Security and is for ease of reference only, and
  - (g) this Standard Security (and any provisions of it) or any other document referred to in this Standard Security shall be construed as references to it for the time being as amended, varied, supplemented, restated, substituted, replaced or novated from time to time
- 2.2 If any provisions of this Standard Security shall conflict with any term of the Senior Facility Agreement then the relevant term of the Senior Facility Agreement shall prevail
- 2.3 An Event of Default or a Default which is "continuing" is continuing if it has not been waived in writing by the Agent or remedied to the satisfaction of the Agent

#### 3 Security

In security for the payment and discharge of the Liabilities, the Chargor grants a standard security in favour of the Common Security Trustee over the Security Subjects

#### 4 Standard conditions

4.1 The Standard Conditions specified in Schedule 3 to the Conveyancing and Feudal Reform (Scotland) Act 1970, and any lawful variation thereof operative for the time being, shall apply

For the avoidance of doubt, upon the occurrence of an Event of Default which is continuing, the Chargor shall be held to be in default within the meaning of standard condition 9(1)(b) of the Standard Conditions

#### 5 Chargor's obligations

- The Chargor undertakes with the Common Security Trustee that it will on demand, pay and discharge each and all of the Liabilities when due in accordance with the terms of the Finance Documents and will indemnify and keep each Finance Party indemnified from and against all actions, charges, claims, costs, damages, proceedings and other liabilities occasioned by any breach of any covenants, undertakings or other obligations of the Chargor to that Finance Party
- The payment obligations of the Chargor under the Finance Documents shall survive the enforcement of the whole or any part of the Security Subjects
- The obligations hereby undertaken by the Chargor shall bind all person(s) included in the expression "the Chargor" and his, her or their successors and representatives whomsoever all jointly and severally without the necessity of discussing them in their order
- The Common Security Trustee may (without releasing, modifying, rendering unenforceable or otherwise prejudicing the security and liabilities hereby constituted, except insofar as the Common Security Trustee expressly so agrees) allow any person(s) any time or indulgence or enter into, renew, vary or end any arrangement, security or guarantee with any person(s)
- Any person who under this Standard Security is liable for the debts of another shall not in competition with or in priority to the Common Security Trustee make any claim against that other nor take or share in or enforce any security in respect of such debts, until such debts have been paid to the Common Security Trustee in full, nor shall such liability be affected by the existence of any other security or guarantee nor by any other security or guarantee being or becoming void or unenforceable, and the Common Security Trustee may place to the credit of a suspense account for so long as it considers desirable any moneys received in respect of such debts without any obligation to apply them towards payment of such debts, and in applying moneys towards payment of such debts the Common Security Trustee may appropriate them towards such part(s) of the debts as it thinks fit

#### 6 Warrandice

And the Chargor grants warrandice but excepting therefrom (a) the lease between Sydney & Ballater Properties Limited and Tulip Glasgow Limited and Pilot Hotels Limited dated 21 November 2002 and registered in the Books of Council and Session on 21 April 2003 the tenant's interest in which is registered in the Land Register of Scotland under Title Number GLA166043, (b) the interposed lease between Sydney & Ballater Properties Limited and Townside Limited dated 11 and 18 March 2005 (as varied, amended and assigned) and registered in the Land Register of Scotland under Title Number GLA180407, and (c) the substation lease amongst Townside Limited,

SP Distribution Limited, Tulip Inn Glasgow Limited and Pilot Hotels Limited dated 14 March 2007 and 21 November 2007 and another date

#### 7 Consent to Registration

The Chargor and the Common Security Trustee consent to the registration of these presents for preservation and execution

#### 8 Governing Law

This Standard Security and any non-contractual obligations arising out of or in connection with it shall be governed by and construed in accordance with Scots law
