Director's Report 2016-17

Review of Activities

Throughout the year, the Chairman and Directors continued searching for every opportunity to promote the case for professional theatre in Farnham to serve the public in the surrounding geographical area. Two of FTA's Directors sit on the Board of Performers Together CIC alongside two non-FTA Directors, who represent the many self-sufficient performing arts organisations in and around Farnham. We gave our support to two small local professional theatre companies and contacted a number of the actors who appeared at the Redgrave or Castle Theatres for their recollections and anecdotes and published these in our regular Newsletter and on FaceBook. FTA Members were also encouraged to record their activities at either theatre to demonstrate support for our shared cause. This is producing additional content for our forthcoming booklet produced to commemorate the 20th anniversary of the unfortunate closure of the Redgrave Theatre.

FTA continues to be responsible for maintaining and protecting the archives of both the Castle and Redgrave Theatres, which are housed at the Surrey History Centre at Woking. The remainder of the collection is currently being assessed, sorted and placed into safe storage. We objected to planning applications for the demolition of the Redgrave Theatre in line with recommendations of the National Planning Policy Framework and responded to Farnham's Neighbourhood Plan, Waverley Borough Council's Cultural Strategy and Local Plan. We supported a group of 5 local residents, which included 3 FTA members, in seeking legal advice on whether judicial review of the decisions involving the demolition the Redgrave Theatre would be feasible. On the advice of the Chairman of the Institute of Theatre Designers, together with the Farnham Society we have instigated and support an alternative plan 'Brightwells Restored' for the retention of the Redgrave Theatre as part of a community trust development.

Members Subscription and Donations returned to their 2015 levels over the last 12 months rising to £790 along with Donations which increased from £50 to £460 this year. As always we are delighted to receive donations from home and abroad as our communication with supporters generate interest in all our activities. Raising income continues to be essential particularly printing and postage to reach members who do not yet have access to emails. Our regular Newsletters, website and FaceBook page attracts enduring support from the public and the world of theatre, including Fischer Dachs Associates, an international company of theatre designers and planners who offered to assist our charitable enterprise. Many high profile actors from the stage and screen encourage our endeavours

Membership renewals from subscriptions help to cover our running costs and we are once again indebted to the support and unceasing work of our Directors, Volunteers and Supporters who make the running of FTA possible. FTA did not hold any significant fund-raising events this year but are very proud that we applied 100% of our funding expenses towards benefiting members, supporters and the general public.

Charitable objects

The Farnham Theatre Association Ltd. is governed by its memorandum and articles of association. The object of the charity is to support and promote the development of theatre by and for the education and entertainment of the people of Farnham and surrounding areas.

Organisation Description

Details of the company's directors and managing committee are given on page 2. Directors are required to be members of the Association and the number of directors must be at least 3. The directors may appoint other directors by resolution and any such director must retire at the next annual general meeting. The company is limited by guarantee. On the winding up of the company the members will each be required to contribute a sum not exceeding £10.
