

#### **Definitions**

"Assigned Agreements" means the Hedging Agreements, the Insurances and any other agreement designated as an Assigned Agreement by the Chargor and the Security Agent,

"Intellectual Property" means the Intellectual Property Rights owned or used by the Chargor throughout the world or the interests of the Chargor in any of those Intellectual Property Rights, together with the benefit of all agreements entered into or the benefit of which is enjoyed by the Chargor relating to the use or exploitation of any of those Intellectual Property Rights,

"Intellectual Property Rights" means all patents and patent applications, trade and service marks and trade and service mark applications (and all goodwill associated with any such registrations and applications), all brand and trade names, all copyrights and rights in the nature of copyright, all design rights, all registered designs and applications for registered designs, all inventions, all trade secrets, all know-how and all other intellectual property rights throughout the world,

"Investment" means any stock, share, debenture, loan stock, security, interest in any investment fund and any other comparable investment (whether or not marketable) whether owned directly by or to the order of the Chargor or by any trustee, fiduciary or clearance system on its behalf (including, unless the context otherwise requires, the Subsidiary Shares),

"Senior Facilities Agreement" means the £379,500,000 facilities agreement dated 18 September 2006, as amended and restated from time to time, between, amongst others, the Chargor and the Security Agent,
