#### Dividends and results

The directors do not recommend the payment of a dividend in the current period (2013: £nil). The company had a result for the year of £nil (2013: £nil) and the net liabilities as at 30 June 2014 were £369 (2013: £369).

The directors consider the future prospects of the company to be satisfactory.

#### Going concern

The company is a property company with net current liabilities and net liabilities at 30 June 2014. The financial statements have been prepared on the going concern basis because the parent company, Tottenham Hotspur Limited, stated that it will provide the necessary financial support to the company for at least twelve months from the date these accounts are signed. The parent company directors prepare budgets and forecasts and have produced detailed and realistic cash flow projections which are reviewed on an ongoing basis. These demonstrate that the parent company has the financial capability to satisfy this obligation.

## Notes to the accounts Year ended 30 June 2014

#### 1. Accounting policies

The financial statements are prepared in accordance with applicable United Kingdom law and accounting standards. The particular accounting policies adopted, which have been applied consistently throughout the current and prior period, are described below.

#### Accounting convention

The financial statements are prepared under the historical cost convention.

#### Cash flow statement

Under the provisions of Financial Reporting Standard 1 (Revised) the company has not presented a cash flow statement as Tottenham Hotspur Limited, a company registered in England and Wales, the parent undertaking of the largest and smallest group which includes the company, prepares consolidated financial statements which include the results of the company and contains a cash flow statement.

#### **Group Accounts**

The company is exempt from preparing and delivering consolidated financial statements under s400 of the Companies Act 2006 as it is included in the consolidated financial statements of the larger group headed by Tottenham Hotspur Limited.

#### Going concern

The company is a property company with net current liabilities and net liabilities at 30 June 2014. The financial statements have been prepared on the going concern basis because the parent company, Tottenham Hotspur Limited, stated that it will provide the necessary financial support to the company for at least twelve months from the date these accounts are signed. The parent company directors prepare budgets and forecasts and have produced detailed and realistic cash flow projections which are reviewed on an ongoing basis. #### Fixed asset investments

Investments held as fixed assets are stated at cost less provision for impairment.
