1 Accounting policies

Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Contractual commitments

The company contracts with third parties in its own name for the supply of services to the land for maintenance of common parts. At 30th June 2015 the company had not entered into any non-cancellable contractual commitments (2014 - None)

Income and expenditure

The company has no income or expenditure in its own right. All transactions in the year relate to maintenance of the common parts. Income and expenditure arising from these transactions is shown in separate service charge accounts for Dellbrook Court Management that do not form part of the annual accounts for the company and are not filed at Companies House. All service charge monies received from the residents of Dellbrook Court are held in trust for the residents.
