1. INTRODUCTION

- I, Paul Boyle, together with my partner David Clements, of Harrisons Business Recovery and Insolvency Limited, 102 Sunlight House, Quay Street, Manchester M3 3JZ was appointed as Joint Liquidator of A & E Services (Midlands) Limited (the Company) on 4 June 2014 This report provides a summary of the outcome of the liquidation of the Company which has now been completed
- 1 2 The trading address of the Company was 1262 Evesham Road, Astwood Bank, Worcester B96 6AD
- 1.3 The registered office of the Company was changed to 102 Sunlight House, Quay Street, Manchester M3 3JZ and its registered number is 06287933.
- The EC Regulation on Insolvency Proceedings 2000 applies to the Liquidation. The proceedings are main proceedings as defined by Article 3 of the Regulation The Company is based in the United Kingdom.
- The liquidation commenced on 4 June 2014 with estimated asset values of £548.00 and anticipated liabilities of £73410.55 After taking into account the costs of liquidation, it was not anticipated that there would be a return to creditors. I would confirm that no dividend was declared in the liquidation.

2. Realisation of Assets

Attached at Appendix A is my cumulative Receipts and Payments Account for the full period of the liquidation from 4 June 2014 to 1 October 2015.

Asset category

2 1 Cash at Bank

At the date of appointment, the sum of £569 90 was held in the Company's bank account with Barclays Bank plc and has been recovered for the benefit of creditors.

2 2 Motor Vehicles

The Statement of Affairs showed that the Company had owned three motor vehicles prior to the liquidation. This included a Fiat Ducat Minibus registration DU06 KXB which was sold when it was no longer required and two Ford Focuses registration numbers LM05 XCH and YC56 KVE which had been transferred to successor company A & E Services (UK) Limited prior to the liquidation.

These assets were retrospectively valued by Michael Gabel MRICS of JPS (Surveyors) Limited ('JPS'), professional agents and valuers, following the appointment of the Joint Liquidators who was able to confirm that the vehicles had been sold and transferred for appropriate amounts.

Similarly, JPS were able to confirm that the Company had no interest in two motor vehicles subject to leasing agreements, namely Volkswagen Touareg registration VK60 JVN and Saab registration number LC09 YTB, which had been returned to the respective financing companies prior to the appointment of the Joint Liquidators

2.3 **Director's Deposit for Costs**

Director Kenneth Douglas Hadley paid the sum of £6030.10 plus VAT to the liquidation estate as arranged with the Joint liquidators prior to their appointment in order to support the costs of the Statement of Affairs and the liquidation

2 4 Other Assets

The sum of £9 41 was received in respect of bank interest on the monies held in the liquidation bank account

There will be no further realisations in this matter

3. Investigations

- In accordance with the Company Directors Disqualification Act 1986, I would confirm that I have submitted a report on the conduct of the Directors of the Company to the Department for Business, Innovation & Skills As this is a confidential report, I am not able to disclose the contents
- 3 2 Shortly after appointment, I made an initial assessment of whether there could be any matters that might lead to recoveries for the estate and what further investigations may be appropriate. This assessment took into account information provided by creditors either at the initial meeting or as a response to my request to complete an investigation questionnaire. My investigations have not revealed any issues requiring further report

4. Outcome for Creditors

4.1 Unsecured Creditors

I received claims totalling £179023 72 from four creditors

I can confirm that the realisations were insufficient to declare a dividend to the unsecured creditors in accordance with the notice issued to all creditors on 15 July 2015

5. Joint Liquidators' Remuneration

- 5.1 Creditors approved that the basis of the Joint Liquidators' remuneration be fixed by reference to the time properly spent by them and their staff in managing the Liquidation
- Attached at Appendix B is a cumulative Time Analysis for the full period of the liquidation from 4 June 2014 to 1 October 2015 which provides details of the total time costs since the date of appointment
- The majority of time costs incurred in this matter relate to the general administration of the case including statutory reporting obligations and the statutory investigation into the conduct of the directors
