AND UPON READING the evidence

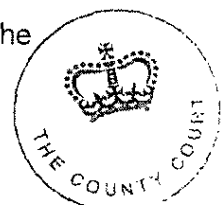
AND IT APPEARING that there is no opposition on behalf of Her Majesty to

Register of Companies

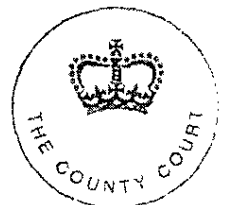
(2) the Company do continue in Members' Voluntary Liquidation
