**WRITTEN RESOLUTIONS OF THE SOLE MEMBER**

**LIFE MARKETING CONSULTANCY LIMITED (the "Company")**

**Circulation date:** 15 October 2019

The undersigned, being the **SOLE MEMBER** of the Company entitled to receive notice of and to attend and vote at a general meeting of the Company, hereby **RESOLVES** and agrees that resolutions below are passed as ordinary resolutions and special resolutions (the "**Resolutions**"), as applicable, pursuant to and in accordance with Chapter 2 of Part 13 of the Companies Act 2006 and the Resolutions shall be for all purposes valid and effective as if the same had been passed at a general meeting of the Company duly convened and held. For the purpose of the Resolutions, capitalised terms used but not otherwise defined shall have the meaning given in the draft minutes of a meeting of the board of the Company appended as Appendix A hereto.

**SPECIAL RESOLUTIONS**

1. **THAT** the articles of association of the Company be amended by inserting the words "Subject to Article 72, " at the beginning of Article 71.
2. **THAT** the articles of association of the Company be amended by inserting a new article 72 as follows:

**"SECURED SHARES**

72.1 Notwithstanding anything contained in these Articles, the Directors of the Company may not decline to register any transfer of shares in the Company and may not suspend any registration thereof and no prior consent of any shareholder of the Company shall be required, where that transfer is:

72.1.1 to a Secured Party and/or a company or other entity to whom such shares are transferred at the direction of a Secured Party and/or a Receiver;

72.1.2 delivered to the Company for registration by a Secured Party in order to perfect its security over the shares; or

72.1.3 executed by a Secured Party or a Receiver pursuant to a power of sale or otherwise under such security,

and, furthermore, notwithstanding anything to the contrary contained in these Articles no transferor of any shares in the Company (or proposed transferor of

those shares) and no Secured Party or a Receiver shall be required to offer the shares which are or are to be the subject of any such transfer to the Members for the time being of the Company or any of them, and no Member shall have any right under these Articles or otherwise to require such shares to be transferred to them whether for consideration or not. Furthermore, notwithstanding anything contained in these Articles, where a security interest has been granted over any share in favour of a Secured Party, such share shall be exempt and released from all liens (whether present or future) in favour of the Company that would arise pursuant to these articles of association or otherwise and the Company and the Directors shall not be entitled to exercise any lien which the Company has in respect of those shares.

**72.2 In this Article 72:**

**72.2.1** a Secured Party means a bank, financial institution, trust, fund or other entity which is regularly engaged in or established for the purpose of making, purchasing or investing in loans, securities or other financial assets to which a security interest (including by way of mortgage or charge) has been granted over shares in the Company and any affiliate of any such person, an agent or trustee acting for any such person or such affiliate or a nominee of any of the foregoing.

**72.2.2** a Receiver means any administrator, administrative receiver, receiver or receiver and manager or similar entity appointed by a Secured Party.”

**ORDINARY RESOLUTIONS**

3. **THAT** it would be for the benefit of the members as a whole that the Company enters into and/or performs its obligations under the Documents.
4. **THAT** the terms and transactions contemplated by, and the execution and delivery by the Company of, the Documents, as applicable, and any additional documents ancillary, necessary or incidental to the Documents (including any directors/formalities certificates, utilisation requests, drawdown requests or selection notices) to which the Company is a party and the performance by the Company of its obligations thereunder be and are hereby approved, in each case, in the form produced to the members with such amendments thereto as any Authorised Person may in their absolute discretion approve.
5. **THAT** the authorising of:
  - (a) each Authorised Person (or in the case of a deed, any two Authorised Persons or an Authorised Person in the presence of a witness who attests the signature) to approve the terms of the transactions contemplated by the Documents or any other documents in connection with the financing relating to the Acquisition and to execute, on behalf of the Company (as a deed or otherwise), the Documents to which it is a party, in the form produced to the meeting, with any amendments or modifications that the Authorised Person may in their sole and absolute discretion approve (the Authorised Person’s signature of the relevant Document being conclusive evidence of the agreement to such amendments or modifications) and any other documents in connection with the Documents or the financing be and is hereby approved; and

(b) each Authorised Person individually or jointly:

- to sign and/or despatch on behalf of the Company all documents and notices to be signed and/or despatched by the Company in connection with the financings contemplated by the Credit Agreements;
- to act individually or with any other Authorised Person on behalf of the Company to execute and deliver any agreement, power of attorney, deed or other document that the Authorised Person deems (in their sole and absolute discretion) to be required, necessary or expedient to be executed and delivered in connection with the financings contemplated by the Credit Agreements; and
- to do all other acts and things that the Authorised Person may consider in their sole and absolute discretion necessary or desirable in connection with the Documents (and the transactions contemplated therein),

subject in each case to such amendments, amendments and restatements, supplements, modifications, renewals, replacements, substitutions and extensions that the Authorised Person may at their sole and absolute discretion approve, be and is hereby approved.

6. **THAT** the Authorised Persons are instructed and authorised to take any action in connection with the negotiation, execution, delivery and performance of the Documents as they shall deem necessary or appropriate.
7. **THAT** the provision of any guarantee and/or security by the Company pursuant to the terms of the Documents and the entry by the Company into the Documents to which it is a party and the performance of the transactions contemplated thereby will promote the success of the Company for the benefit of its members as a whole, and be to the further benefit and advantage of the Company.
8. **THAT** any act done or document executed pursuant to the foregoing resolutions shall be valid, effective and binding on the Company notwithstanding any limitation on the powers of the directors of the company contained in or incorporated by reference in the Company's articles of association (such limitation being hereby suspended, disappplied, waived, relaxed or abrogated to the extent requisite to give effect to the foregoing resolutions).
9. **THAT** any steps taken or act done by any Authorised Person in connection with the Acquisition and the Documents, including but not limited to any steps and acts listed in this Resolution, prior to the time of this meeting be approved, authorised and ratified.
