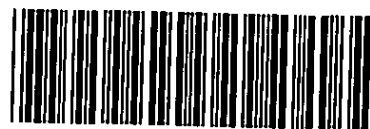




Directors responsibilities
