1. **ACCOUNTING POLICIES**

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Income

Income represents the management charges levied on property owners to enable the company to pay for communal property costs. The total charges are estimated at the beginning of the year. Turnover is recognised in the accounts to the extent that it is required to cover expenditure for the year, and any surplus is held on Trust in the company bank account.

2. **CASH AT BANK**

The bank account is held in Trust for the flat holders and consequently is not shown as belonging to the company. The bank balance at 31 December 2014 amounted to £20,799.84.
