**UPON** the Petition presented to this Court on 12 January 2012 by the Applicants which sought:

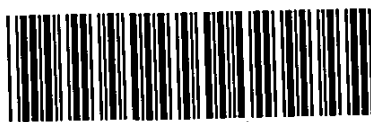
- 1 the end of the administration of the Company which commenced on 26 October 2010;

**IT IS ORDERED THAT:**

- 1 The Applicants' appointment as Joint Administrators effective from 15 August 2011 shall cease to have effect pursuant to paragraph 79(1) of Schedule B1 to the Insolvency Act 1986 with immediate effect
- 2 The Applicants be discharged from liability pursuant to paragraph 98(1) of Schedule B1 to the Insolvency Act 1986 with effect from 5 March 2012
- 3 This hearing be treated as the return day of the petition pursuant to rule 4.22 of the Insolvency Rules 1986 and any requirement for the advertisement and service of the Petition is dispensed with under rule 4.23(1) of the Insolvency Rules 1986
- 4 The Company shall be wound up by this Court under the provisions of the Insolvency Act 1986 with immediate effect
- 5 Stephen John Hunt and Timothy James Bramston are appointed as Joint Liquidators of the Company pursuant to section 140(1) of the Insolvency Act 1986 with immediate effect subject to rule 4.102 of the Insolvency rules 1986.
- 6 Any act required or authorised under any enactment to be done by a liquidator may be done by either or both of the joint liquidators pursuant to section 231 of the Insolvency Act 1986
- 7 The final report to creditors shall be in the form of the report at pages 48-65 of Exhibit SJH1.
- 8 The remuneration payable out of the Company's property pursuant to paragraph 99(3) of Schedule B1 to the Insolvency Act 1986 shall be fixed on a time basis pursuant to rule 2.106 of Schedule B1 to the Insolvency Act 1986.
- 9 The costs of and occasioned by the petition be paid as an expense of the administration of the Company.
