

B He will notify the Register of Companies immediately on the conclusion of the actions

C The Director of the Company will immediately on the expiry of 3 months from the conclusion of the actions apply to the Register of Companies for the voluntary strike off of the Company under Section 1003 of the Companies Act 2006 and comply with all relevant requirements for such an application

- 3. An Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existance as if its name had not been struck off.
- 4. The Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- 5. The Claimant do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300.00
