#### 1 Accounting Policies

#### Basis of accounting

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

#### **Turnover**

Turnover comprises the invoiced value of goods and services supplied by the company, including Value Added Tax and trade discounts

#### Deferred taxation

Deferred taxation anses when items are charged or credited in accounts in different periods to those in which they are included in the company's tax computations

Deferred tax is provided in full on timing differences that result in an obligation to pay more (or less) tax at a future date. Deferred tax is calculated at the average rates that are expected to apply when the timing differences reverse, based on current tax rates and laws. The resulting deferred tax asset or liability is not discounted.

#### **Dividends**

Proposed dividends are only included as habilities in the financial statements when their payment has been approved by the shareholders prior to the balance sheet date

#### Tangible fixed assets

Tangible fixed assets, other than freehold land, are stated at cost or valuation less depreciation and any provision for impairment. Depreciation is provided at rates calculated to write off the cost or valuation of fixed assets, less their estimated residual value, over their expected useful lives on the following basis.

#### Stocks and work in progress

Stocks and work in progress are valued at the lower of cost and net realisable value as follows:
