- (1) **Princess Yachts (Holdings) Limited**, a company incorporated under the laws of England and Wales with registered number 06409725 having its registered office at C/O Princess Yachts Limited, Newport Street, Plymouth, United Kingdom, PL1 3QG (the **Parent**);
- (2) **Princess Yachts Limited**, a company incorporated under the laws of England and Wales with registered number 00856633 having its registered office at Newport Street, Stonehouse, Plymouth, Devon, PL1 3QG (the **Company**, the Company and the Parent together being the **Chargors**); and
- (3) **National Westminster Bank Plc** as agent and trustee for the Secured Parties (the **Security Agent**).

**Recitals**

- A The Security Agent and the Chargors have entered into a debenture (the **Debenture**) dated 16 May 2019, as supplemented pursuant to supplemental debentures dated 20 February 2020 and 28 June 2020 between such parties.
- B The Chargors, the Security Agent and others have entered into, or are proposing to enter into, an amendment and restatement agreement (the **Amendment Agreement**) under the terms of which the parties to the Facilities Agreement agree to amend and restate the Facilities Agreement (the Facilities Agreement as amended and restated pursuant to the Amendment Agreement being the **Restated Facilities Agreement**).
- C Pursuant to a loan note instrument dated 28 June 2020 as amended from time to time including by an amendment agreement dated on or about the date of this Deed, the Company has issued £4,921,201.62 GBP loan notes and \$3,536,644.34 USD loan notes due 2021/2022 to the Noteholders (as defined below). The liabilities of the Company under such loan notes are to be secured under this Deed, along with the liabilities of the Chargors under the Finance Documents.
- D Each Chargor has agreed to enter into this Deed to charge its respective business, assets and undertaking as a continuing security for the payment and discharge of the Secured Liabilities notwithstanding the changes made to the Finance Documents (as defined in the Facilities Agreement) pursuant to the Amendment Agreement.
- E The conditions precedent to the effectiveness of the amendments to the Facilities Agreement set out in the Amendment and Restatement Agreement include the entry by the Chargors into this Deed.
- F This Deed is a Transaction Security Document.

1.1 Unless this Deed expressly provides otherwise, any capitalised term in this Deed, or any term deemed to be incorporated in this Deed, shall have the same meaning as it would have in the Debenture.

1.2 In this Deed,

**Intercreditor Agreement** means an intercreditor agreement dated 28 June 2020 as amended from time to time including on or around the date of this Deed, between, among others, National Westminster Bank plc as Agent, the Super Senior Creditors, the Senior Lenders, the Hedge Counterparties and Princess Yachts Limited and Princess Yachts (Holdings) Limited as Original Debtors (each such term as defined therein);

**Loan Note Instrument** means the instrument dated 28 June 2020 as amended from time to time including by an amendment agreement dated on or about the date of this Deed pursuant to which £4,921,201.62 GBP loan notes and \$3,536,644.34 USD loan notes due 2021/2022 issued by Princess Yachts Limited are, or are to be, constituted;

**Noteholders** means the following entities:

- (a) Princess Lendco LLC;
- (b) Delphine S.A.S.;
- (c) Westley International S.A.;
- (d) Ulran S.A.; and
- (e) CA Indosuez (Switzerland) S.A..

**Secured Liabilities** means the Secured Obligations as defined in the Intercreditor Agreement;

**Secured Parties** has the meaning given to such term in the Intercreditor Agreement;

**Security** means a mortgage, charge, pledge, lien or other security interest securing any obligation of any person or any other agreement or arrangement having a similar effect;

**Security Assets** means:

- (a) the assets mortgaged, charged or assigned by way of security to the Security Agent by this Deed, any Accession Deed or any Supplemental Debenture, including but not limited to the assets listed in Schedule 1 (*Security Assets*); and
- (b) any assets held on trust by a Chargor for the Security Agent; and

**Security Period** means the period from the date of this Deed until the date on which the Security Agent has determined (acting reasonably) that all of the Secured Liabilities have

been irrevocably and unconditionally paid and discharged in full and that no commitment is outstanding.

### 2 Covenant to Pay

Each Chargor as primary obligor covenants with the Security Agent (as trustee for the Secured Parties) that it will on demand pay to the Security Agent the Secured Liabilities when the same fall due for payment.

### 3 Creation of Security

#### 3.1 Fixed charges

As a continuing security for the Secured Liabilities, each Chargor charges in favour of the Security Agent, with full title guarantee, the following assets, from time to time owned by it or in which it has an interest:

- (a) by way of first legal mortgage, each Property; and
- (b) by way of first fixed charge:
  - (i) all Property not effectively mortgaged under sub-clause 2.1(a)
  - (ii) all fixed and permanent Plant and Machinery;
  - (iii) all Plant and Machinery not effectively charged under sub-clause 2.1(b)(ii) above;
  - (iv) all Shares;
  - (v) all Debts;
  - (vi) all Blocked Accounts;
  - (vii) all Other Accounts;
  - (viii) all Investments;
  - (ix) all Hedging Agreements;
  - (x) all Intellectual Property Rights;
  - (xi) any Charged Agreement;
  - (xii) its goodwill and uncalled capital; and
  - (xiii) if not effectively assigned by way of security pursuant to sub-clause 2.2 (*Security assignment*), all its rights and interests in (and claims under) the assets described in sub-clause 2.2 (*Security assignment*).

### 3.2 Security assignment

As security for the payment of the Secured Liabilities, each Chargor assigns, by way of security, with full title guarantee to the Security Agent all its rights, title and interest in:

- (a) the Insurances and the Insurance Proceeds;
- (b) each Assigned Contract; and
- (c) all Related Rights in respect of each of the above.

### 3.3 Floating charge

- (a) As further security for the payment of the Secured Liabilities, each Chargor charges with full title guarantee in favour of the Security Agent by way of floating charge its undertaking and all its present and future assets other than those assets which are effectively charged by way of first fixed charge or legal mortgage under sub-clause 2.1 (*Fixed charges*) or which are effectively assigned by way of security under sub-clause 2.2 (*Security assignment*).
- (b) Paragraph 14 of Schedule B1 to the Insolvency Act 1986 shall apply to the floating charge created by this Deed.

### 3.4 Miscellaneous

This Deed is supplemental to the Debenture and subject to the Intercreditor Agreement. Other than to the extent this Deed expressly provides otherwise:

- (a) Clause 4 (*Nature of security*) of the Debenture is incorporated into this Deed in relation to the Security created under Clauses 3.1, 2.2 and 2.3 of this Deed as though references to the Debenture are to this Deed; and
- (b) the rights, obligations, consents and other terms in the Debenture relating to the Security granted under it, shall be incorporated in reference to the Security granted under Clause 3.1, 2.2 and 2.3 of this Deed, as if set out in full in this Deed.

## 4 Registration at Companies House

Each Chargor consents to the registration of this Deed at Companies House pursuant to Part 25 of the Companies Act 2006.

## 5 Trust

- 5.1 The Security Agent holds the benefit of this Deed on trust for the Secured Parties in accordance with the terms of clause 18 (The Security Agent) of the Intercreditor Agreement.
- 5.2 The perpetuity period for any trusts created by this Deed is 125 years.

## 6 Negative Pledge

No Chargor shall create or permit to subsist any Security over any Security Asset except for Permitted Security or for Security arising under a Permitted Transaction.

## 7 Continuing Debenture

**EXECUTION VERSION**

- 7.1 Nothing in this Deed is intended to imply, or should be construed as implying, that the Security created under the Debenture is not effective to secure the Secured Liabilities. The Debenture shall continue in full force and effect as supplemented by this Deed.
- 7.2 The performance of, and compliance with, any undertaking, requirement or obligation by each Chargor under this Deed constitutes the performance of, and compliance with, the corresponding undertaking, requirement or obligation under the Debenture and further, the performance of, and compliance with, any undertaking, requirement or obligation by each Chargor under the Debenture will be deemed to constitute the performance of, and compliance with, the corresponding undertaking, requirement or obligation by that Chargor under this Deed (in each case, other than to carry out any registration or filing including the registration of this deed at Companies House pursuant to section 859 of the Companies Act 2006), including, for the avoidance of doubt and without limitation, the provision of any documents by a Chargor pursuant to clause 7.2(b) (*Deposit of Documents or Title Deeds*) of the Debenture which shall discharge the obligation to provide the same documents under this Deed.

**8 HM Land Registry**

- 8.1 In relation to each Property from time to time, each Chargor irrevocably consents to the Security Agent applying to the Chief Land Registrar for a restriction to be entered on the Register of Title of all that Property (including any unregistered properties subject to compulsory first registration at the date of this Deed) on the prescribed Land Registry form and in the following or substantially similar terms:

*"No disposition of the registered estate by the proprietor of the registered estate is to be registered without a written consent signed by the proprietor for the time being of the debenture dated • in favour of • referred to in the charges register."*

- 8.2 The Finance Parties must perform their obligations under the Facilities Agreement (including any obligation to make available further advances). In relation to each Property, the Security Agent may apply to the Chief Land Registrar for a notice to be entered onto the Register of Title of all that Property (including any unregistered properties subject to compulsory first registration at the date of this Deed) of the obligation to make further advances.

**9 Incorporation of Terms of the Debenture**

- 9.1 The provisions of Clause 3.4 (*Conversion of floating charge by notice*), Clause 3.5 (*Automatic conversion of floating charge*), Clause 3.6 (*Small company moratorium*), Clause 3.7 (*Third party consents to lease*), Clause 5.1 (*General*), 5.3 (*Register of Intellectual Property Rights*), Clause 5.4 (*Notices*) and Clause 6 (*Representations and warranties*) to Clause 10 (*Powers of a Receiver*) excluding Clause 7.2(a)(i) and Clause 12 (*Protection of third parties*) to Clause 19 (*Miscellaneous*) of the Debenture shall be deemed to be incorporated into this Deed with all necessary modifications as if they were set out in full in this Deed, but as if references in those clauses to:

- (a) "this Debenture" or "this deed" and other similar expressions were a reference to this Deed;
- (b) "Event of Default" means an Event of Default as defined in the Facilities Agreement, an Event of Default as defined in the Loan Note Instrument or a failure to comply with a demand under clause 2 (*Covenant to pay*);
- (c) "Chargor" was a reference to the Chargor under this Deed;

- (d) "Secured Liabilities" was a reference to the Secured Liabilities under this Deed;
- (e) "Security" was a reference the Security under this Deed;
- (f) "Security Period" was a reference to the Security Period under this Deed; and
- (g) "Security Assets" (including references to relevant specific assets within the Security Assets), was a reference to the assets charged under this Deed.

9.2 The representations and warranties made in Clause 6 of the Debenture and incorporated by reference into this Deed shall be made on the date hereof by reference to the facts and circumstances on that date.

**10 Acknowledgement by the Security Agent**

The Security Agent acknowledges and confirms that the creation of any Security pursuant to (and the compliance by the Chargor with the terms of) this Deed does not and will not constitute a breach of any representation, warranty or undertaking in any Finance Document.

**11 Application of Monies**

Notwithstanding anything contained in the Debenture, all monies received or recovered by the Security Agent or any Receiver pursuant to this Deed shall be applied in the order and manner specified in clause 16 (*Application of Proceeds*) of the Intercreditor Agreement.

**12 Counterparts**

This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

**13 Further provisions**

The provisions of clauses 1.2 (*Construction*), 1.3 (*Law of Property (Miscellaneous Provisions) Act 1989*), 1.5 (*Effect as a deed*), and 1.7 (*Finance Document*), of the Debenture shall be incorporated into this Deed.

**14 Governing law**

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

**15 Jurisdiction**

- 15.1 The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a dispute relating to the existence, validity or termination of this Deed or any non-contractual obligation arising out of or in connection with this Deed) (a "**Dispute**").
- 15.2 The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
- 15.3 This clause is for the benefit of the Security Agent only. As a result, the Security Agent shall not be prevented from taking proceedings relating to a Dispute in any other courts with

jurisdiction. To the extent allowed by law, the Security Agent may take concurrent proceedings in any number of jurisdictions.
