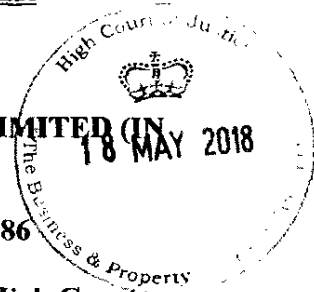

ORDER

UPON the Application issued on 17 May 2018

AND UPON hearing Miss Feng, Counsel for the Applicants

AND UPON reading the evidence

IT IS ORDERED THAT:

1. The proceedings listed in the Schedule to the Order attached be transferred to the High Court of Justice, Business and Property Courts in Manchester, Insolvency and Companies, solely for the purpose of the determination and disposal of this Application upon which they be transferred back to the Court from which they were transferred.
2. The First Respondent be removed from the insolvency officeholder appointment of each of the insolvency estates listed in the Schedule to this Order and be

replaced in each case by either the First Applicant or the Second Applicant as indicated, with immediate effect.

3. The First Respondent be discharged from liability as office-holder 21 days after the publication of a notice in the Gazette as provided for by paragraph 4 of this Order.
4. The First and Second Applicant be permitted to publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette within 14 days of receipt of the sealed Order and do file any appropriate notices in respect of the removal of the Respondent and the appointment of the First and Second Applicant appointed pursuant to paragraph 2 of this Order (the New Office-Holder) with the Secretary of State for Business, Energy & Industrial Strategy (Insolvency Service) as may be required.
5. Subject to paragraphs 6 and 7 below, in the event that, as a result of the implementation of the Order, OBS Recovery incurs any additional cost over and above those costs incurred in the ordinary course of the administering those insolvency estates where the Respondent was the office-holder, such costs shall be borne by OBS Recovery and shall not be charged as an expense of any of those insolvency estates.
6. Nothing contained in paragraph 5 shall prejudice the First or Second Applicant or the First Respondent from charging to each insolvency estate the cost of obtaining an Insolvency Practitioner's licence bond in respect of that insolvency estate.
7. Nothing contained in paragraph 5 shall prejudice the First or Second Applicant or the First Respondent from apportioning between the said insolvency estates equally the cost of the composite Gazette notice to be placed under paragraph 4 above.
8. Without incurring any additional expense for any of the said insolvency estates, the First and Second Applicant shall notify each creditor of this Application and

this Order by way of notice in the next routine report that shall be due to the creditors of each insolvency estate, such notice to contain the following matters:

- a) an explanation of the effect of the Order;
 - b) express reference to the liberty to apply contained in paragraph 9 below; and
 - c) the provision of all such information as might reasonably be required with regard to the conduct of the relevant insolvency estate.
9. Liberty to each creditor of each estate to apply to vary or discharge this order within 21 days of the receipt of the notice directed to be sent under paragraph 8 above, whichever is the sooner.
10. There be no order as to costs.
