

NOTES TO THE ABBREVIATED ACCOUNTS FOR THE PERIOD ENDED 31 MARCH 2011

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

1.2 Turnover

Turnover comprises revenue recognised by the company in respect of consultancy services supplied during the period, exclusive of Value Added Tax and trade discounts.

1.3 Going concern

At the balance sheet date the company had a shareholders' deficit of £10,310. The directors have confirmed they believe the company will continue to trade profitably for the foreseeable future and therefore the accounts have been prepared on a going concern basis.
