1. General information

DS Smith Supplementary Life Cover Scheme Ltd ("the Company") is a limited company incorporated and domiciled in England and Wales whose shares are not publicly traded. The registered office is located at 350 Euston Road, London, NW1 3AX.

2. Accounting policies

2.1 Basis of preparation of financial statements
