### 1. General information

The company is a private company limited by shares, registered in England and Wales. The address of the registered office is 571 Fishponds Road, Bristol BS16 3AF.

### 2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland'.

### 3. Accounting policies

#### Basis of preparation
