Eight non-preferential creditors have proved in the liquidation with aggregate claims amounting to £40,598. Further creditors totalling an estimated £10,404 appear entitled to prove in the liquidation, but as no dividend will be paid I am taking no further action with regard to those creditors.

No dividend will be available for any class of creditor.

Liquidator's Remuneration

At the statutory meeting of creditors of the company held on 23 February 2012 a resolution was passed confirming that my remuneration be fixed in accordance with Rule 4.127(2)(b) of the Insolvency Rules 1986, that is to say by reference to the time properly given by the insolvency practitioner (as liquidator) and his staff in attending to matters arising in the winding up

Time spent by my staff and myself in relation to this matter amount to 158 hours totalling £3,634, an average hourly rate of £230.
