Respective responsibilities of directors and auditors



1 ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

Compliance with accounting standards

The financial statements are prepared in accordance with applicable United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), which have been applied consistently (except as otherwise stated)

Preparation of consolidated financial statements

The financial statements contain information about Velocity Healthcare Limited as an individual company and do not contain consolidated financial information as the parent of a group. The company has taken the option under Section 398 of the Companies Act 2006 not to prepare consolidated financial statements

Exemption from preparing a cash flow statement

Exemption has been taken from preparing a cash flow statement on the grounds that the company qualifies as a small company

Turnover

Turnover represents net invoiced sales of goods, excluding value added tax

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date

Going concern

The business is dependent on the continued support of its bankers AIB. The company's losses have been funded by funds introduced by the directors from associated companies. The shares in the company were sold on 20th April 2011 and as a result of this and the revaluation of the property the accounts have been prepared on a going concern basis with the balance sheet of the company showing a positive net asset value

4 RELATED PARTY DISCLOSURES

Subsidiary undertaking

The company holds 99% of Revona LLP, a UK partnership. The principal activity is that of a healthcare provider. The aggregate amount of capital and reserves of Revona LLP was a deficit of £2,575,150 and the loss for the ten months period to 31st January 2011 was £784,424.

The income received during the year was from Revona LLP, ultimately under the control of the directors. Velocity Healthcare Ltd granted a one year rent holiday to Revona LLP starting from 1 April 2010.

In this particular year, under the terms of the lease issued to the subsidiary Revona LLP, there was an overall rent rebate of £26,071 (2010- rent charged £535,000).

Associated company creditors

Other creditors consist of funds owed to a related party, Montpelier Estates Ltd, which provided financial assistance in the past.

Montpelier Estates (Park Royal) Ltd is an associated company creditor with a balance of £360,000.

5 POST BALANCE SHEET EVENTS

Negotiations are taking place for the sale of the shares and were concluded on 20th April 2011. The net amount due from the subsidiary is £146,600 and its recoverability is dependant on the new shareholders and their intentions with regards to the Group.

6 ULTIMATE CONTROLLING PARTY

The directors control the company by virtue of their direct interest in the whole of the issued share capital.
