BEFORE His Honour Judge Cooke sitting at 33, Bull St. Birmingham on the 7th March 2011

UPON THE APPLICATION of Andrew William Shackleton and Lyn Marie Green ("the  
Applicants") by notice dated 25 January 2011

AND UPON HEARING Counsel for the Applicants

AND UPON READING THE evidence filed

AND UPON READING two letters from Mark Botwood dated 4th & 7th March 2011

AND UPON the Court dispensing with the requirement contained in r 7 10C(7)(b) of the  
Insolvency Rules 1986 for Mark Botwood as joint office holder with Lyn Marie Green to be made  
a Respondent to these proceedings

IT IS ORDERED that -

1 The proceedings listed in the Schedules to this Order be transferred to the High Court for the  
purpose only of considering and if thought fit making the orders sought in the Application Notice  
herein dated 25th January 2011.

2 In relation to the voluntary arrangements set out in Schedule A (Parts 1&3) hereto, Andrew  
William Shackleton be appointed supervisor in place of Lyn Marie Green and in relation to  
the voluntary arrangements set out in Schedule A (Part 2) hereto, Lyn Marie Green be removed  
as supervisor

3 In relation to all the company winding up proceedings set out in Schedule B (Parts 1 to 4, 6  
& 8) hereto, Andrew William Shackleton be appointed liquidator of the companies in liquidation  
in place of Lyn Marie Green and in relation to the company winding up proceedings set  
out in Schedule B (Parts 5&7) hereto, Lyn Marie Green be removed as liquidator The Witness  
Statement of Andrew William Shackleton dated 25 January 2011 do stand as his statement for

the purposes of Rule 4.103 of the Insolvency Rules 1986

4. In relation to the administration proceedings set out in Schedule C hereto, Andrew William Shackleton be appointed administrator of the company in administration in place of Lyn Marie Green

5. In relation to all the bankruptcies set out in Schedule D (Parts 1 & 2) hereto, Andrew William Shackleton be appointed trustee of the bankrupts' estates in place of Lyn Marie Green.

6 Any creditor who is affected by this Order shall have permission to apply to the Birmingham District Registry of the Chancery Division to vary or discharge the same within 28 days of receiving notice of it.

7 Andrew William Shackleton shall within 28 days of the date of this Order:-

a. cause to be placed in The London Gazette an advertisement listing the insolvency matters identified in the Schedules hereto, giving notice of the making of this Order and stating that any creditor who is affected by this Order has permission to apply to the Birmingham District Registry of the Chancery Division to vary or discharge the same within 28 days of the date of the advertisement, and

b. serve notice of the making of this Order on all known creditors concerned in the insolvency matters identified in the Schedules hereto and stating that any creditor who is affected by this Order has permission to apply to the Birmingham District Registry of the Chancery Division to vary or discharge the same within 28 days of the date of the notice

8 Lyn Marie Green be at liberty to apply in relation to obtaining her release in respect of any of the insolvency matters listed in the Schedules hereto

9 The costs of this Application be provided for as follows:-

a. such remuneration, costs, or expenses in respect of this Application as are referable to a particular matter in the Schedules shall be fixed and paid in the ordinary way as remuneration, costs, or expenses in respect of such matter,

b. such costs or expenses in respect of this Application as are not referable to a particular matter in the Schedules shall be fixed and paid in the ordinary way as remuneration, costs, or expenses and divided equally between the various matters in the Schedules and thereafter treated as costs or expenses of such matters;

c. provided that in no circumstances shall the costs payable pursuant to this Order in relation to a particular matter exceed 10% of the value of the realised assets in that matter
