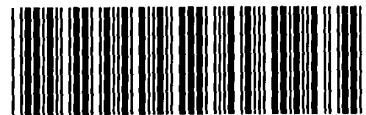

The directors submit their annual report and the financial accounts of the company for the 12 months ended 28/02/19.

The principal activity of the company is to:

- Advance the education of children, young people and adults by creating connections between schools and neighbourhoods, to enable young people and adults to find out about different ways of life and values, to celebrate diversity and promote mutual respect and understanding.
- All Directors/ supporters have given their time voluntarily to Friends Out There.

Business Review

This year the turnover was nil. The FOT Director has volunteered this year to promote the values-based creative curriculum education programme designed in the previous year, by speaking to educators and practitioners in the fields of education participation and liaising with the Neem Foundation on embedding the programme in its school. Teachers were trained following the development of a teacher training resource guidance by FOT Director, and the creative curriculum is continued to be used on a weekly basis in Lafiya Sarari Learning Centre, Maiduguri, in Nigeria. The FOT Director has explored possible funding streams over the year, but no further action has been taken due to other work commitments.

Links have continued with Bluebird Primary and Secondary School in Port Harcourt in Nigeria and St Maria Goretti Secondary School in Nigeria.

Any costs for activities (petrol, materials and company filing costs) are donated by Directors.

The balance for the year ending 28/02/19 is £227.98

There are no dividends to declare. All Directors have given their time voluntarily to carry out the projects and activities for Friends Out There and there are no staff employed by Friends Out There. There are no other assets.

Financial Control

The directors acknowledge responsibility for the company's system of internal financial control and believe the systems including the computerization of the company's financial accounts are appropriate to the business. No material losses or contingencies have arisen during the 12 months period that would require disclosure by the directors.


