

Aims and Objectives

To promote the relief of people over 50 in any manner which now is or hereafter may be deemed by law to be charitable within the County of Bedfordshire and surrounding areas.

Services

Bedford Guild House is open from Monday to Friday as a meeting place for anyone over 50 years of age. There is a wide choice of activities on offer including snooker, carpet bowls, art classes, beadwork, crafts, sewing, play reading, computer sessions, belly dancing, line dancing, tea dance, tai-chi, whist, bridge, bingo, scrabble, darts, dominoes, walking, keep-fit, pilates and more.

The Guild House is a popular place for lunches and snacks, served every day at very reasonable prices. We employ a Care Assistant who will help any frail or special needs people enabling them to take part in any activities they wish. This also provides a much needed respite service for family carers.

Holidays are arranged each year, both home and overseas. One holiday is a special needs holiday designed for those who need the help of a carer in order to attend.

The Main Hall and other meeting rooms can be hired by local organisations for a reasonable fee. Catering facilities are also available. There is also a wheelchair loans scheme.

On the practical side, we have a foot specialist and hairdressing for both men and women. Holistic therapies such as reflexology and massage, manicures and pedicures, beauty therapy, etc are now available in our adjoining premises next door at 58 Harpur Street. Benefits advice, pensions and other community groups hold regular sessions at the Guild House.

CHAIRMAN'S REPORT

2007 – 2008 has been a landmark year in the history of Bedford Guild House. During the year your Committee recognised that for the Guild House to meet the challenges of the future and negate trustee's liability, it was essential to change our status to a Charity Limited by Guarantee. This required undertaking a vast amount of administrative work updating and modifying our practices and procedures to comply with Company House requirements. Much of the preparatory work was undertaken during the autumn and winter to ensure this was both the right decision and achievable within the Guild House structure.

At a Special General Meeting held on 19th February 2008 the members gave the Trustee's the mandate to proceed with the change of status. Although we were unable to complete the process within our financial year, we are now a Charity Limited by Guarantee. As previously mentioned the change in status has generated a tremendous additional workload for the staff. It is a great credit to Sonia and her team that this work has gone on in the background and hopefully has had little impact on the day to day running of the Guild House.

Unfortunately our change of status does not alleviate us from the constant need to secure funding to meet the ever increasing costs of the Guild House. Maggie Proctor must again be complimented on her hard work and success in securing grants and funding in an ever competitive environment.

With the change of status I feel that the time is right for me to step down as Chairman. After five enjoyable years, in which the Guild House has grown and developed, I believe the organisation now requires someone who is able to have a more frequent involvement. I would like to thank the Staff, Trustee's and Volunteers for their support and hard work during these last five years. Finally I would like to wish Bedford Guild House a long and successful future in providing friendship, entertainment and opportunities to its members.

HONORARY TREASURER'S REPORT FOR THE YEAR TO 31 JULY 2008

This is my first year as Honorary Treasurer and, having only recently on retirement become involved with Bedford Guild House, have enjoyed getting to know the people and taking part in some of the activities.

This financial year is made up of 16 months instead of the usual 12 months. This is due to becoming a Charity Incorporated by Guarantee from 1st August 2008. Rather than produce accounts for 12 months to 31st March 2008, then for 4 months to 31st July 2008, the Charity Commission have allowed us this dispensation. It means that year on year comparisons are not useful.

The large deficit this year is mainly because of the difficulty of attracting grants; consequently our reserves are rather lower than we would like. We are doing twice as much in the way of holidays, activities and outings but we need to continue to control costs yet still provide a good range of quality services.

I am grateful to the Chief Officer, assisted by a volunteer, in keeping the books satisfactorily.

CHIEF OFFICER'S REPORT

This has been a difficult year with many administrative duties brought about by the word 'incorporation'. However, like lots of problems nothing was insurmountable and we seem to be coming out of the fog into easier times.

At this Annual General Meeting we will appoint our Board of Directors and from them will be the appointment of Chairman, Vice-Chairman and Treasurer. Incorporation just changes the liability of our trustees and life at the Guild House should continue as before.

Our biggest problem is as always, raising enough money to keep our heads above water and with the current international financial crisis I am sure the knock on effect will be even more difficult times for small voluntary groups like ours to survive. We must, therefore, all pull together to ensure our continuation.

On a happier note, I look back over the last fifteen months as a time when more and more activities have taken place and our client numbers have increased. It is always satisfying to hear people say they don't know what they would have done without the Guild House and it has made all the difference to their lives.

We like to be innovative with our activities and in April we spent a very pleasant day in Brussels, via Eurostar; so enjoyable that we went to Paris in September and plan to go to Lille early next year. Our holidays, particularly the supported break which we do annually, are increasing in demand. If only we could get more single rooms we would find it much easier to accommodate people.

Once again I must mention the support we receive from our staff and volunteers, the Guild House could not exist without them. My grateful thanks go to them all. Our president, Bill Greenish, sadly passed away in early August. The commitment Bill made to the Guild House over many years was second to none and we have all missed her welcoming presence since her illness prevented her from attending.

Development Officer's Report

Despite not wanting to kick off on a gloomy note, this year has been a struggle in terms of securing sufficient running costs. The cost of rent, utilities, salaries etc have to be found before we can even begin to look at projects, new activities, extra equipment and so on. We are grateful to those grant making trusts which see the sense in supporting core cost funding but they are becoming scarce although not extinct yet.

So, what else should we do? Currently we try to engage our service users in fundraising activities and are grateful to those who agree to help. We have also increased the number of lettings at weekends and evenings which is helpful but these alone are not enough. Other local charities experience similar problems and this has been recognised by Ian Curtis, collaborative working officer at Community and Voluntary Services for Mid and North Bedfordshire. Ian invited representatives from local charities to come together to form a Partnership organisation to develop charitable work locally and to promote gift making or legacies to local people by way of a legacy pack to be distributed to solicitors, accountants and other advisory bodies. The Partnership will also organise and deliver fundraising events throughout the year. This is a new and exciting project for local charities and we hope it will be well supported.

His Grace, the Duke of Bedford hosted our 6th annual classic car run (The Bunyan Run) in June. In keeping with tradition, we had glorious weather and an even larger turnout of classic and vintage cars. We are grateful to His Grace for supporting Bedford Guild House and look forward to continuing The Bunyan Run from Woburn over the coming years.

This year we held our first Italian Dinner and Dance at Bromham Village Hall, which was very well attended. My thanks to everyone who came along and for the hard work put in by Lynne Moliterno, our hairdresser.

My thanks, as always, to everyone who plays a part in helping to keep Bedford Guild House a special place – our service users, volunteers, trustees, and colleagues. It is impossible to name everyone but please be assured you are very much appreciated.

I hope the coming year will be a successful one.
