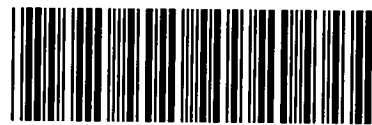

Directors' Responsibilities


