UPON the application of the Applicants dated 22 May 2019 for a block transfer order

AND UPON READING the papers on the court file recorded as having been read

IT IS ORDERED that:-

- Each of the County Court cases listed in the First Schedule and the Second Schedule attached
 to this order (together the "Schedules") be transferred to the High Court of Justice, Chancery
 Division, Manchester District Registry for the purpose only of making this order.
- Immediately upon this order taking effect, the County Court cases listed in the Schedules be transferred back to the County Court.



- Ian Soloman Robert Franses (the "outgoing office-holder") be removed from office in respect
 of each of the on-going cases listed in the Schedules (the "block transfer cases") from the
 date of this order.
- Jeremy Karr (the "first replacement office-holder") be appointed as replacement office-holder
