IT IS ORDERED THAT:

- 1. The proceeding listed in Schedule A hereto be transferred to the Companies Court of the Chancery Division of the High Court of Justice for the purpose only of considering and if thought fit making the orders contained in paragraphs 3 to 17 of the Application and that the Applicants do ensure that a sealed copy of the order transferring the case to the High Court and of every order which may be made as a result of this application be lodged with the court having jurisdiction over the case affected by such order for filing on the court file relating to that case
- 2. The proceeding listed in Schedule A hereto be transferred back to the relevant County Court after making the orders contained in paragraphs 3 to 17 of the Application
- 3 In respect of the proceedings listed in Schedules B to L attached hereto, Christopher Michael White be removed from office with effect from the order of the Court.
- In respect of those companies in administration listed in Schedule B hereto, John Russell be appointed as joint administrator in place of Christopher Michael White with effect from the order of the Court Further, upon filing of a paragraph 83 Schedule B1 notice transferring the administration into creditors' voluntary liquidation, John Russell be appointed as joint liquidator in place of Christopher Michael White, as at the date of registration of the notice pursuant to paragraph 83 of Schedule B1
- 5. In respect of those companies in administration listed in Schedules C and D hereto, Gareth David Rusling be appointed as joint administrator in place of Christopher Michael White with effect from the order of the Court. Further, upon filing of a paragraph 83 Schedule B1 notice transferring the administration in creditors' voluntary liquidation, Gareth David Rusling be appointed as joint liquidator in place of Christopher Michael White, as at the date of registration of the notice pursuant to paragraph 83 of Schedule B1
- 6. In respect of the creditors' voluntary liquidations listed in Schedules E and I hereto, John Russell be appointed as joint liquidator in place of Christopher Michael White with effect from the order of the Court

- 7. In respect of the creditors' voluntary liquidation listed in Schedule F, Ashleigh William Fletcher be appointed as joint liquidator in place of Christopher Michael White with effect from the order of the Court
- 8. In respect of the creditors' voluntary liquidations listed in Schedules G, H and J hereto, Gareth David Rusling be appointed as joint liquidator in the place of Christopher Michael White with effect from the order of the Court.
- In respect of the compulsory liquidation listed in Schedule K hereto, John Russell be appointed joint liquidator in place of Christopher Michael White with effect from the order of the Court.
- In respect of the company in company voluntary arrangement set out in Schedule L hereto, Gareth David Rusling be appointed as joint supervisor in place of Christopher Michael White with effect from the order of the Court.
- The provisions contained in Rule 2 47(3A) of the Insolvency Rules 1986 ("Rules") (Prescribed period when Administrator ceases to act), Rule 4 49C(3) of the Rules (Prescribed period when a Creditors' Voluntary Liquidator ceases to act) and Rule 4 49B(5) of the Rules (End of period of progress report in respect of companies in Compulsory liquidation) shall not apply and as such, there shall be no requirement to produce progress reports upon Christopher Michael White ceasing to act as Administrator or Liquidator, as the case may be
- In respect of the proceedings listed in Schedules B to L attached hereto and the consequent appointments of John Russell, Gareth David Rusling or Ashleigh William Fletcher as joint office holders as set out in paragraphs 3 to 10 above any act required or authorised under any enactment to be done by the office holders may be done by one or more of the person or persons for the time being holding that office

E to K until after the expiry of 28 days from the date when the relevant notice referred to in paragraph 16 below has been given.

- There be liberty to each creditor of the insolvency estates listed in the attached schedules to apply to vary or discharge this order insofar as it relates to the insolvency estate of which that person is a creditor within 28 days of the Notice (as defined in paragraph 16 below)
- 16. The Applicants give notice of this Order to all creditors of the estates listed in Schedules B to L within 14 days of the date of this Order by means of an advertisement in the London Gazette ("Notice"). The Notice shall explain.
 - 16 1 the effect the Order made and that all creditors have permission to apply for reconsideration of the Order (insofar as it relates to an estate of which he is a creditor) provided that any such application is made within 28 days of the date of the Notice,
 - 16.2 the right of the First Respondent to apply to the Secretary of State for his release in respect of his insolvency appointments listed in Schedules E to K upon the expiry of 28 days from the date of the Notice save in respect of claims notified by that date,
 - 163 creditors' rights to call for statements under regulation 11 (in liquidations) of the Insolvency Regulations 1994;
 - that where there is a creditors' committee it is open to that committee to require an account of the First Respondent's administration and that, where there is no committee, it is open to an individual creditor to apply to the Court within 28 days of the Notice to require such an account

For the avoidance of all doubt, notice of this Order must also be given to the creditors of the estates list in Schedule B to L in the next statutory report to the creditors and members of those estates
