On 19 February 2009, as a partner in The Vanguard No. 1 Partnership, the Company made a capital contribution of £44,759 in accordance with an Additional Contribution Agreement.

On 2 April 2009, Baligay Limited purchased the entire 116,000 shares in Ram Initiatives Limited for £47,218. The directors consider this to be the most appropriate basis upon which to value the company's investment in The Vanguard No. 1 Partnership, and as such have written the investment down to this recoverable amount at 31 March 2009.
