

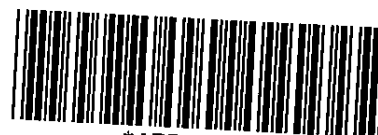

The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt totalling £5,292,967 due from BOP (Leadenhall Court) SARL, the Company's immediate parent. The debt will be distributed by set off prior to the closure of the liquidation.

A notice to creditors to prove their claims in the liquidation was advertised in the London Gazette on 1 October 2015. No creditors were forthcoming as a result of this advertisement.

Tax

All pre-liquidation corporation tax matters were handled by KPMG Tax who prepared and submitted all outstanding returns up to the date of the commencement of the liquidation to HM Revenue & Customs ("HMRC"). The Joint Liquidators requested that HMRC confirm that the Company has no outstanding corporation tax returns or liabilities, that it will not raise enquiries into any pre or post liquidation periods and that it has no objection to the Liquidators taking steps to conclude the liquidation. A response is still awaited.

A similar assurance has been sought and received from HMRC in respect of PAYE and VAT matters.

Distributions

No distribution were made during the period of this report.

Closure

The Liquidators' will take steps to conclude the liquidation upon receipt of tax clearances.

Joint Liquidators' remuneration and expenses

A written resolution was passed on 23 September 2015 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.

In the event, the Liquidators' remuneration has been paid by another group company and accordingly no detailed analysis is included in this report.
