There be no Order as to costs save that the Applicants' costs of this application be charged as a cost or expense of the estates listed in the Schedules (each estate to bear an equal share, or such other share as the Applicants, in their sole discretion, may decide but with no estate having to bear an amount exceeding 10 percent of the available funds in that estate);
24. Any cases listed in the Schedules which, pursuant to paragraph 2 above, are transferred to the Birmingham District Registry be transferred back to the County Court or District Registry from which they originated immediately prior to the making of this Order,
