South Coast Accident Repair and Refurbishment Limited - In Liquidation

I write to you pursuant to Rule 4 49B of the Insolvency Act 1986 and provide a progress report detailing my first year in office.

I enclose, for your information, a summary of my receipts and payments to date showing a balance in hand of £984 16 and report as follows

Receipts

As previously reported Clydesdale Bank Plc operated an invoice financing facility that is secured against the company's book debts. The director's statement of affairs indicated that book debts of £494,598 were available for collection. Due to what appears to be evidence of invoicing irregularities, set-off for non completion of work and the inability to locate a number of invoices for significant sums I have only collected £18,780. The ledger has been returned to the Bank for further investigation.

Plant and machinery realised £61,668.

Payments

The payments are self explanatory but I would comment on the following:

Agent Fees

Proudley Associates Limited was engaged to market and realise the company's assets. An on site auction was convened in December 2010. A significant amount of work was required to remove the assets from site and the company was paid £11,642 for its services.

Legal Fees

Messers Lamport Bassitt have been paid £2,069 and were engaged to assist in general insolvency matters including retention of title and correspondence with the company's director.

Messers Moore Blatch were engaged specifically for debt collection purposes and have been paid £240.

Secretary of State and Official Receiver Fees

As the company is in a compulsory procedure I am required to hold funds with the Insolvency Service. An ad Valorum fee is deducted from deposits to the account. £10,405 has been deducted from the account as a result of these fees. A further £8 has been charged to the account in transaction fees.

The Official Receiver charges an administration fee of £2,235. A further disbursement of £468 for changing locks at the premises has also been charged.

Petitioning Creditor's Costs

The legal cost to the petitioning creditor of petitioning is payable from the estate and in this instance amounts to £2,324

Fixed Charge Creditor

Clydesdale Bank Plc operated an invoice financing facility that is secured against the company's book debts. £11,798 of the book debt recovery has been paid to the Bank under their security

Liquidators' Remuneration

The creditors have approved the Liquidators' remuneration on a time costs basis and to date I have drawn £32,145 in respect of remuneration as shown on the attached receipts and payments account. A further £1,659 has been drawn in direct relation to the collection of book debts as agreed with the Bank on a percentage of recovery basis. I attach a schedule which summarises the time costs drawn to date and indicates the work undertaken in that respect

A further £57 had been drawn in relation to disbursements

Prospects for Creditors

Under Section 176A of the Insolvency Act 1986 where after 15 September 2003 a company has granted to a creditor a floating charge, a proportion of the net property of the company must be made available purely for the unsecured creditors.

Unfortunately in this instance the net property is insufficient to declare a distribution to unsecured creditors under the prescribed part
