SUCH VOTE SHALL BE TENDERED BY WHICHEVER OF THE JOINT MEMBERS AS IS PRESENT AT THE MEETING OR BY THE JOINT MEMBER NAMED FIRST IN THE COMPANY'S REGISTER OF MEMBERS IF ALL ARE PRESENT AT THE MEETING.
