SPECIAL RESOLUTION

REDUCTION OF SHARE CAPITAL

THAT, subject to the re-registration of the Company as a private limited company, the share capital of the Company be reduced to 1,000 A ordinary shares of £1 (being the 1,000 A ordinary shares of £1 registered in the name of Patrick McKenna) and 1 B ordinary share of £1 (being the 1 B ordinary share registered in the name of Ingenious Holdings Limited) by the cancellation of 4000 B ordinary shares of £1 each (the **Capital Reduction**) **AND THAT**, following the registration of the Capital Reduction, the sum of £1,894,240 be paid to the B ordinary shareholders (at the rate of 473 56 per B ordinary share) subject to the Capital Reduction
