1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015).

Turnover

Turnover represents net invoiced sales of services, excluding value added tax, except in respect of service contracts where turnover is recognised when the company obtains the right to consideration.

Going concern

As at 30 November 2016 the company's current liabilities exceeded its current assets by £1,452 (2015: £4,525). The financial statements have therefore been prepared on a going concern basis, the validity of which depends on the support continuing to be made available or alternative funding being arranged. The directors' have expressed willingness to support the company for the foreseeable future & based on their support the company is able to continue trading at present.
