### 1. Owner's Obligations

The Owner will pay to the Bank on demand all the Owner's Obligations. The Owner's Obligations are all the Owner's liabilities to the Bank (present, future, actual or contingent and whether incurred alone or jointly with another) and include:

- Interest at the rate charged by the Bank, calculated both before and after demand or judgment on a daily basis and compounded according to agreement, or, in the absence of agreement, quarterly on the days selected by the Bank.
- any expenses the Bank or a receiver incurs (on a full indemnity basis and with Interest from the date of payment) in connection with:
- 1.2.1 the Property charged by Clause 2. References to Property include any part of it.

### 2. Charge

The Owner, as a continuing security for the payment on demand of the Owner's Obligations and with full title guarantee, gives to the Bank:

- a fixed charge over the following property of the Owner, owned now or in the future:

- 2.1.7 the benefit of any hedging arrangements, futures transactions or treasury instruments.
- 2.2 a floating charge over all the other property, assets and rights of the Owner owned now or in the future which are not subject to an effective fixed charge under this deed or under any other security held by the Bank.

### Appointment of Receiver or Administrator 3.

The Bank may appoint or remove a receiver or receivers of the Property, or appoint an administrator of the Owner.

#### 4. Restrictions

The Owner will not, without the Bank's consent:

- permit or create any mortgage, standard security, charge or lien on the Property. 4.1
- dispose of the Property charged by Clause 2.1. 4.2
- dispose of the Property charged by Clause 2.2, other than in the ordinary course of business. 4.3
- call on, or accept payment of, any uncalled capital. 4.4
- deal with its book and other debts, except by collecting them in the ordinary course of its 4.5 business. In particular, the Owner will not realise its book and other debts by means of invoice discounting or factoring arrangements.
- grant, or accept a surrender of, any lease or licence of any of its Land or consent to a tenant 4.6 assigning or sub-letting.
