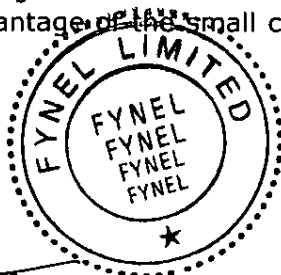
DIRECTORS

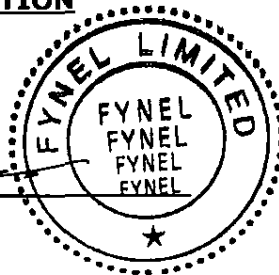

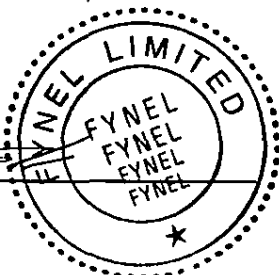
