

Variation

(1) Dividends

Any dividend will be paid in cash on the nominal value paid up or credited as paid up on of the Shares (unless in relation to any Share, less than the nominal value of the Share has been paid in which case the amount to be paid will be on the amount paid up on the Share) in respect of which it is payable and will belong to and be paid to the holders of the relevant class of Shares pro rata according to their holdings of such class.

As regards income, subject to the provisions of the Companies Act, the Company may by ordinary resolution, and upon the recommendation of the directors, declare a dividend which may be declared and paid in respect of one class of Shares or more to the exclusion of the other classes or class of Shares or differentiate between the classes of Share as to the amount or percentage of dividend payable.

(2) Return of Capital

All classes of Share shall rank pari passu on a return of capital whether on a winding up or dissolution (other than a redemption of Shares or the purchase by the Company of its own Shares), and each Member shall be entitled to share rateably in the capital so returned in proportion to the amount that the paid up nominal share capital represented by his Shares bears to the aggregate paid up nominal share capital of the Company.

Any return on a particular class of Shares will be made amongst their holders pro rata as nearly as possible to their respective holdings of Shares of that class.

(3) Voting

The Shares shall confer on the holders the voting rights set out in section 284 of the Companies Act as if all references in that section to "each share" were references to "each Equity Share".
