1. ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

Turnover

The turnover shown in the profit and loss account represents amounts invoiced during the year, exclusive of Value Added Tax

Financial instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.

Where the contractual obligations of financial instruments (including share capital) are equivalent to a similar debt instrument, those financial instruments are classed as financial liabilities. Financial liabilities are presented as such in the balance sheet. Finance costs and gains or losses relating to financial liabilities are included in the profit and loss account. Finance costs are calculated so as to produce a constant rate of return on the outstanding liability.

Where the contractual terms of share capital do not have any terms meeting the definition of a financial liability then this is classed as an equity instrument. Dividends and distributions relating to equity instruments are debited direct to equity

Pension contributions

The company makes regular payments on behalf of its director into a Personal Pension Plan. The payments are made on a defined contribution basis, and the Plan constitutes a Money Purchase Scheme. The company accounts for the pension premiums as they fall due.

2. RELATED PARTY TRANSACTIONS

The company was under the control of Mr A Borlase throughout the year Mr Borlase is the managing director and majority shareholder

Mr Borlase was owed by the company £3,979 at the year end (2009 owed by Mr Borlase to the company £5,137) The maximum balance outstanding during the year was the opening balance of £5,137 Interest was charged on the loan at the Official Rate of Interest for the period it was overdrawn. The balance was cleared early in 2010
