The directors, who are also the charity Trustees, present their report together with the financial statements of the charity for the 15 month period ended 31 December 2010

Structure, Governance and Management

Abdul Latif Jameel Foundation is a company limited by guarantee incorporated on 17 February 2009. On 3 August 2009 the company was registered under number 1130939 as a registered charity. The number of members is limited by the Articles of Association to ten and no person can become a member unless they are also a director.

Directors are invited to the Board based on their expertise and relevance to the role. The Board is reviewing the procedures for appointing new directors with a view to introducing a formal induction and training programme so that new directors are fully aware of their responsibilities as Trustees of the charity

Objectives and Activities

The main objectives of the charity are

- To develop and promote a portfolio of globally applicable sustainable projects and solutions centering on poverty reduction, education, arts, culture, heritage and science
- To bring about reduction in poverty through novel and innovative schemes, mechanisms, projects, education and training
- To demonstrate sustainable projects and solutions whose schemes and mechanisms can be modelled, copied and replicated by others

The trustees have given due consideration to the Charity Commissioner's published guidance on the operation of the public benefit requirements

Achievements and Performance

During the period the Abdul Latif Jameel Foundation has worked hard to focus on its core aims as detailed above. The Abdul Latif Jameel Foundation has made the following progress against its objectives during the period. Three main projects were focused upon 1001 Inventions, Jameel Prize and Edge of Arabia.

With regard to 1001 Inventions. Discover the Muslim Heritage in Our World, this is a touring exhibition that traces the forgotten story of a thousand years of science from the Muslim world, from the 7th century onwards. The free to visit exhibition looks at the social, scientific and technological achievements that are credited to the Muslim world, whilst celebrating the shared scientific heritage of other cultures. The exhibition is a British based project, produced in association with the Jameel Foundation. Featuring a diverse range of exhibits, interactive displays and dramatisation, the exhibition shows how many modern inventions, spanning fields such as engineering, medicine and design, can trace their roots back to Muslim civilisation.

1001 Inventions has positively changed public perception and helped to educate millions of people with 1001 Inventions delivering

- Major international media coverage in 35 countries
- · High profile international exposure to the Abdul Latif Jameel Foundation name and brand
- An exhibition described as London's most successful new block buster exhibition
- · Visitation by large numbers of VIP's including ministers, ambassadors and heads of state
- Almost 300,000 exhibition visitors including children and families since January 2010
- Over 2,000,000 online downloads of 1001 Inventions film with Ben Kingsley (winner of twenty International awards including Best Education Film)
- . More than a million website visitors to 1001inventions com and its related sites

Abdul Latif Jameel Foundation Trustees' Report

With regard to the Jameel Prize, it is an international art prize launched by the Victoria and Albert Museum in 2009 in which the prize is awarded to a contemporary artist or designer for work inspired by Islamic traditions of craft and design. The competition is held every two years, with a prize of £25,000.

The Jameel Prize aims to raise awareness of the thriving interaction between contemporary practice and its rich artistic heritage, and to contribute to a broader debate about Islamic culture. The previous Prize selected nine artists and designers whose output is very varied, reflecting the richness and diversity of the Islamic traditions that inspired them. The pieces exhibited at the Victoria and Albert Museum and on the world tour varied in scale, and the media employed ranges from jewellery to photomontage to turned woodwork to screen prints. The works show how dynamic Islamic tradition can be, and how complex and eloquent the art and design inspired by this tradition has become. For the second Jameel Prize, nominations have been received and are undergoing review and selection, wherein artists and designers will be short-listed by the panel of judges.

With regard to Edge of Arabia, this project is a platform for Saudi artists, curators and art enthusiasts to have exhibitions, share ideas and discuss possibilities with the international art world as well as the local arts community. With this integrated approach, it hopes to inspire a positive and timely discussion about Saudi contemporary art, and ultimately bring what is at present quite an isolated arts community, into the mainstream conversation.

Edge of Arabia has to date brought twenty-four relatively unknown and undeveloped artists to the attention of the world though providing several international exhibitions, web sites, personal mentoring, strategic carrier, art advice and personal and financial investment in the artists, delivering

- Introducing 8 new artists to the international public, participation in more than four major events including Riyadh (1,000 visitors), Dubai (3,000 visitors), Istanbul (largest and most ambitious exhibition to date with a 1,000m2 exhibition and 15,000-20,000 visitors) and Miami, Positioning Edge of Arabia as the leading regional project of its kind
- · Repositioned Saudi contemporary art as being exciting and collectable
- Increased the quality and production level of Saudi contemporary art to meet the requirements of international exhibitors and collectors bringing about a significant international and domestic demand for Saudi contemporary artists by intuitions, galleries and collectors
- Edge of Arabia's successful promotion of new artists has enabled several to be chosen for new
 prestigious exhibitions and events including First Saudi Pavilion Venice Biennale (2011), World Expo
 in Shanghai (2010) and exhibitions at British Museum's, LA County Museum, and at Christies &
 Sotheby's Auctions (London and Dubai)

In conclusion, the trustees are very satisfied with the undertakings of the Abdul Latif Jameel Foundation in relation to meeting its objectives

Financial Review

During the period under review, the charity received donations of £365,343 and incurred expenditure of £365,243. The great majority of the expenditure related to direct charitable activities.

Reserves Policy

The Directors are seeking to build a secure level of reserves for the long term, but the charity is still at an early stage in fundraising

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF ABDUL LATIF JAMEEL FOUNDATION

I report on the accounts of the company for the period ended 31 December 2010, which are set out on pages 5 to 9

This report is made solely to the charity's trustees, as a body, in accordance with Regulation 31 of the Charities (Accounts and Reports) Regulations 2008. My work has been undertaken so that I might state to the charity's trustees those matters I am required to state to them in an independent examiner's report and for no other purpose. Respective responsibilities of trustees and examiner

The trustees (who are also the directors of the company for the purposes of company law) are responsible for the preparation of the accounts. The trustees consider that an audit is not required for this period under section 43(2) of the Charities Act 1993 (the 1993 Act) and that an independent examination is needed. The charity's gross income exceeded £250,000 and I am qualified to undertake the examination by being a qualified member of the Institute of Chartered Accountants in England and Wales.

Having satisfied myself that the charity is not subject to audit under company law and is eligible for independent examination, it is my responsibility

- · to examine the accounts under section 43 of the 1993 Act,
- to follow the procedures laid down in the general Directions given by the Charity Commission under section 43(7)(b) of the 1993 Act, and

1. Accounting Policies

Basis of accounting

The financial statements have been prepared under the historical cost convention and in accordance with the requirements of the Statement of Recommended Practice 'Accounting and Reporting by Charities' (SORP 2005) issued in March 2005 and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008) and the Companies Act 2006

Incoming resources

Voluntary income

Gifts, donations and grants are recognised in the year in which they become receivable. Gifts in kind, which are held for charity activities, are valued at an estimated open market value and recognised when distributed. Donated facilities are valued at an estimated open market value, only if the value can be reasonably quantified, and recognised in the year in which they become receivable.

Resources expended

Resources expended are included in the Statement of Financial Activities on an accruals basis

Charitable activities

Expenditure allocated to this category are costs directly relating to the activities of promoting the direct charitable objectives

Governance costs

Governance costs relate to expenditure incurred on the statutory and legal obligations of running the charity and include the costs of accounting fees and certain legal costs

Fund accounting

Funds held by the charity are either

- Unrestricted funds these are funds which can be used in accordance with the charitable objects at the discretion of the Trustees
- Restricted funds these are funds that can only be used for particular restricted purposes when specified by the donor or when funds are raised for particular restricted purposes

Foreign Currencies

Monetary assets and liabilities expressed in foreign currencies are translated into sterling at the rates of exchange at the balance sheet date. Transactions entered into in foreign currencies are recorded at the rate of exchange ruling at the transaction date. All translation differences are dealt with in the statement of financial activities.
