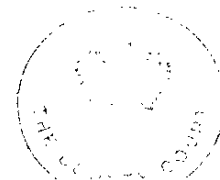
AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

- (5) the hearing fixed for the 18th of October 2018 be vacated



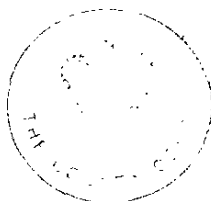
