Assets

The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt of £1 ('the Debt') due from Janus Henderson Administration UK Limited (formerly Henderson Administration Limited) ('JHA'), the Company's immediate parent. The Debt has been distributed by set off (see 'Distributions' below).

Creditors

The declaration of solvency disclosed no creditors. A notice to creditors to prove their claims in the liquidation was advertised in the London Gazette on 16 March 2022. No creditors were forthcoming as a result of this advertisement.

Tax

The Company's tax advisors advised that the Company had dormant corporation tax status.
