

IT IS ORDERED THAT:

- 1. Each of the County Court cases listed in Parts I to VI of the Schedule ("the Schedule")) be transferred to the High Court of Justice, Chancery Division for the purpose only of making this order.
- Immediately upon this order taking effect, the County Court cases listed in Parts I
 to VI of the attached Schedule be transferred back to the respective County
 Court.

OURT OF JUSTICE OF THE PROPERTY COUNTS OF THE

- The Respondent be removed from office in respect of each of the cases listed in Parts I to VIII of the Schedule from the date of this order.
- 4. The First Applicant do remain as the office holder of the cases listed at Parts I to III of the Schedule.
- 5. The Second Applicant do remain as the office holder of the cases listed in Parts IV to VII of the Schedule.
- 6. The Second Applicant be appointed as the replacement office holder in respect of the case listed in Part VIII of the Schedule from the date of this order.
- The creditors in each of the cases listed in the Schedule be notified of this order by advertisement published in the London Gazette within 28 days of the order (the "advertisement").
- 8. Any creditor or member in respect of any of the cases listed in Schedule who has an objection to this order shall have 28 days from the advertisement to apply to Court to set aside or vary the terms of this order. Such application shall not affect the transfer of the cases listed in the Schedule until further or other order by the Court.
- The Applicants gave notice of this Application to the Secretary of State on 19th December 2017.
- 10. The Respondent shall receive his release as Joint Liquidator and Trustee in Bankruptcy of the cases listed in the Schedule 28 days after giving notice to creditors in accordance with this paragraph 7 of this order, save that such release may be subject to further order in the event of an application by any creditor under paragraph 8 of this order for the specific case subject to that application.
- 11. The cost of this application shall be paid as an expense and shall be apportioned between each of the cases listed in the Schedule, up to a maximum of 10% per estate.
