MEMORANDUM OF ASSOCIATION

OF

A Bright Talented Movement Ltd

- 1) The name of the company is A Bright Talented Movement Ltd
- 2) The registered office is to be situated in England and Wales
- 3) The objects of the company are to carry on business as a general commercial company.

Examples of our objects include the following:

- A: To create and establish support services for audio visual works that aid our clients through general activities associated with that of a record label.
- B: Provide additional services associated with the creation promotion and marketing of said client's audiovisual products.
- C: To provide our clients with distribution services for their aforesaid works mentioned in objective A.
- D: To increase our client base.
- F: To acquire from any authority in any part of the world the rights, powers, privileges, grants, and concessions whatsoever which the organisation may deem necessary for the carrying out of its objects.

Within the scope of our operation:

- Provide additional services to cater for the needs of Audio Visual Production services pursuant to objective A.
- II. To engage in the activities and practices necessary in order to implement objective A, for example Studio access, Marketing & Promotion, Legal, Media, and Artists management.
- III. Outsource services such as; providing television and radio broadcast, as well as other specialist services and equipment necessary for the production of audio visual works.
- IV. We may assume the title of management whilst acting under the instruction of the artists that we chose to represent.

Outside the scope of our operation:

- I. We cannot manufacture or produce the plastics, metals and other raw materials necessary to execute objective A.
- II. We cannot manufacture or assemble equipment for the production of Audio Visual works such as; the cameras, lighting and other recording and editing equipment etc.
- III. We cannot manufacture or produce computer components for the assembly of computers or specialist studio or acoustic equipment to carry out our business services.
- IV. It is at the discretion of A Bright Talented Movement Ltd to contribute to the budgets or provide the capital that is required to initiate or sustain marketing and promotional activity for our clients'.
- V. Whereas A Bright Talented Movement Ltd intend to engage in the distribution of said works mentioned in 3 (C). For the purpose of clarity the word distribution does not refer to the building or ownership of outlets where aforesaid works will feature for the consumption of consumers such as; Cinemas, DVD retail outlets, Television and broadcasting channels. However we may seek to mass reproduction of media formats like CD MP3 &4 as well as High Definition, DVD, mini DV etc on which the aforesaid works will feature to be packaged and feature in distribution outlets for the purchase and consumption of consumers. All such activates relating to the definition of distribution as given in this paragraph 3 (V) will be housed internally or done so via third party.

- 4) The liability of its members is limited
- 5) The company's share capital is £100 divided into 100 shares of £1 each
