Transfer of assets

On 28 June 2013 the company transferred all of its fixed assets to HIMOR (Property) Limited. The company has therefore had no property income from that date.

Principal activities

For the period to 28 June 2013 the principal activity of the company was the acquisition and letting of commercial property. Following the transfer of its properties to HIMOR (Property) Limited the company did not trade.

Business performance

The results of the company are in line with expectations and its profit and loss account is set out on page 5.

Proposed dividend and transfer to reserves

The loss on the ordinary activities of the company before taxation amounted to £1,492,000 (2012 loss £59,000). The directors do not propose the payment of a dividend (2012 £nil).





1 Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements, except as noted below

Basis of preparation

The financial statements have been prepared on the going concern basis in accordance with the Companies Act 2006 and applicable accounting standards and using the historical cost convention except in respect of the revaluation of investment properties as set out below

As permitted by Financial Reporting Standard 1, the company has not included a cash flow statement as part of these financial statements, as the company meets the criteria for exemption from preparation of a cashflow statement as a small company

The company has also taken advantage of the exemption included in Financial Reporting Standard 8 "Related Party Disclosures" (para 3) for wholly owned subsidiaries not to disclose transactions with entities that are part of the group

Going concern

On 28 June 2013 the Company transferred 100% of its fixed assets to HIMOR (Property) Limited. From that date the company will receive no rental income. The financial statements have been prepared on a going concern basis, which the directors believe to be appropriate, on the basis that HIMOR Group Limited (the company's parent undertaking) will continue to provide financial support to the extent necessary to enable the company to continue to trade and to pay its liabilities as and when they become due and HIMOR Group Limited have confirmed they will not request repayment of the current intercompany creditor balances within the foreseeable future.

Fixed assets and depreciation

In accordance with SSAP 19, investment properties are revalued annually, the aggregate surplus or deficit is transferred to a revaluation reserve, and no depreciation or amortisation is provided. This treatment may be a departure from the requirements of the Companies Act regarding depreciation of fixed assets but the directors consider that this accounting policy is necessary for the accounts to give a true and fair view, as the properties are held for investment not consumption. Depreciation or amortisation is only one of the factors reflected in the annual valuations and the amount which might otherwise have been shown cannot be separately identified or quantified. The properties are valued at the directors' estimate of open market values.

Revenue

Revenue represents the rental income receivable in the year (excluding value added tax) derived from the provision of site services to customers during the year.

Taxation

The charge for taxation is based on the profit for the year and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes.

Deferred tax is recognised, without discounting, in respect of all timing differences between the treatment of certain items for taxation and accounting purposes which have arisen but not reversed by the balance sheet date, except as otherwise required by FRS 19.

Notes (continued)

Classification of financial instruments issued by the Company

Following the adoption of FRS 25, financial instruments issued by the Company are treated as equity (i.e. forming part of shareholders' funds) only to the extent that they meet the following two conditions

- a) they include no contractual obligations upon the Company to deliver cash or other financial assets or to exchange financial liabilities with another party under conditions that are potentially unfavourable to the Company, and
- b) where the instrument will or may be settled in the Company's own equity instruments, it is either a non-derivative that includes not obligation to deliver a variable number of the Company's own equity instruments or is a derivative that will be settled by the Company's exchanging a fixed amount of cash or other financial assets for a fixed number of its own equity instruments

To the extent that this definition is not met, the proceeds of issue are classified as a financial liability. Where the instrument classified takes the legal form of the Company's own shares the amounts presented in these financial statements for called up share capital and share premium account exclude amounts in relation to those shares

Factors affecting the future tax charge

Legislation to reduce the main rate of corporation tax from 24% to 23% from 1 April 2013 was substantively enacted on 3 July 2012

In addition to the change in rates of Corporation tax disclosed above, further changes to the UK Corporation tax rates were substantively enacted as part of the Finance Bill 2013 on 2 July 2013. These include reductions to the main rate to reduce the rate to 21% from 1 April 2014 and to 20% from 1 April 2015.

Deferred tax has been calculated based on a rate of 20% at the balance sheet date
