

- Packed and delivered 3300 mini seed growing kits to primary schools, SEN schools, community groups and centres, nurseries and pre-schools
- Packed and issued 360 Homemade Family Pizza Kit boxes
- Worked with 160 families on our Family Recipe Kit project who each received four weeks of our bespoke recipe kits (4 x new kits were introduced in the summer of 2021)
- Worked with 9 schools who participated in our Autumn Harvest Soup project, 1 school participated in our Dips and Sticks project
- Delivered a Seniors Meals Service to around 90 vulnerable/isolated elderly South Wye community members.
- Delivered 5 x Cook Clubs and 4 x Gardening Clubs to the long-term unemployed via a Landau/ESF Community Grant
- Delivered 10 Garden Volunteer Days
- Worked with Herefordshire Council, Rose Regeneration Consultants, NMITE and Belmont Wanderers to develop a Southside bid, forming part of Hereford's Stronger Towns Fund
