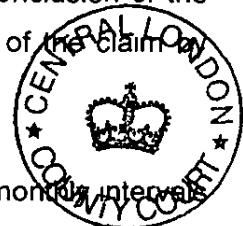
UPON THE APPLICATION by a Claim Form dated 28 December 2014 of Clive Bellman (a protected party by his litigation friend, Nick Bellman), the Claimant, and a Creditor of the above named Northampton Recruitment Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the Waiver letter from the Treasury Solicitor dated the 21 January 2015

AND the Claimant (a protected party by his litigation friend, Nick Bellman) by his Solicitors undertaking to

- (A) Immediately upon restoration of the Company to the Register inform the Registrar of Companies of the title and Court reference number of the litigation against the Company referred to in paragraph 9 of the Witness Statement of Jeremy William Cornwell dated the 18 November 2014
- (B) Inform the Registrar of Companies immediately on the conclusion of the said litigation or any appeal therefrom or the conclusion of the claim or any other means
- (C) Unless the said litigation is completed in the interim, at 6 monthly intervals from the date of the order serve on the Registrar of Companies a full and



sufficient Witness Statement setting out what steps have been taken to progress the said litigation

AND UPON the Solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT

- (1) the name of the above named Northampton Recruitment Limited be restored to the Register of Companies
- (2) the Company do continue in Creditors' Voluntary Liquidation
- (3) if at any date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 6949937
- (4) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (5) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (6) in the event that the Claimant fails to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant
