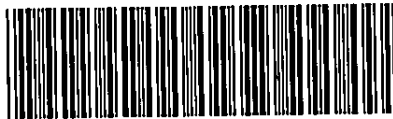

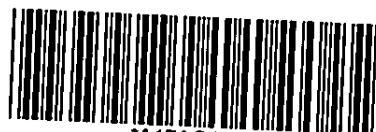

NOTES
