## **Directors' report**

The directors present their directors' report and financial statements of the Company for the year ended 31 August 2015.

### **Principal activity**

The Company was incorporated on 14 August 2009 and is a holding company.

On incorporation the Company was a subsidiary of Virage Logic Corporation Inc, a company quoted on the NASDAQ Global Market. On the 2 September 2010 Virage Logic Corporation was acquired by Synopsys Inc, also a company quoted on the NASDAQ Global Market.

### **Results**

The company does not trade and the only activities in the year were a foreign exchange loss on a US Dollar loan from the parent company an impairment of fixed asset investments in subsidiaries.

### **Going concern basis**

However, post year end, the directors took the decision to cease trading following a management review of the organizational structure of the Group. The directors have not prepared the financial statements on a going concern basis. 

**1 Accounting policies**

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented.

**Accounting convention**

The financial statements are prepared under the historical cost convention and in accordance with Companies Act 2006 and applicable UK accounting standards.

In previous years, the financial statements have been prepared on a going concern basis. However, post year end, the directors took the decision to cease trading following a management review of the organizational structure of the Group. The directors have not prepared the financial statements on a going concern basis. No adjustments were necessary to the amounts at which the remaining assets are included in these financial statements."

The company being a subsidiary undertaking where 90% or more of the voting rights are controlled within the group whose consolidated financial statements are publicly available, is exempt from the requirement to draw up a cash flow statement in accordance with FRS 1.

The Company has also taken advantage of the exemption under paragraph 3 of Financial Reporting Standard 8 ("Related Party Disclosures"), on the grounds that it is a wholly owned subsidiary of Synopsys Inc, whose accounts are publicly available, and accordingly has not provided details of transactions with fellow group companies.

**Group accounts**

The company has not prepared consolidated accounts as it is a wholly owned subsidiary undertaking of Synopsys Inc, as permitted by Section 401 of the Companies Act 2006. These financial statements therefore present information about the company as an individual undertaking and not about its group.

**Investments**

Investments are stated at historical cost less any required provision for impairment. The impairment review is conducted annually by the directors.

**Foreign currency translation**

Monetary assets and liabilities expressed in foreign currencies are translated into sterling at rates of exchange ruling at the date of the balance sheet or at the agreed contractual rate. Transactions in foreign currency are converted to sterling at the rate ruling at the date of the transaction. All differences on exchange are taken to the profit and loss account.

**2 Analysis of profit**

The Company operates as a holding company for its subsidiaries.
