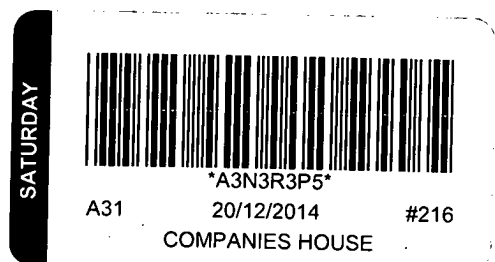

NOTES TO THE ABBREVIATED ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2014

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The full financial statements, from which these abbreviated accounts have been extracted, have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

1.2 Turnover

Turnover comprises revenue recognised by the company in respect of goods and services supplied during the year, exclusive of Value Added Tax.

1.3 Intangible fixed assets and amortisation

Research and development

Expenditure on research and development is written off in the year in which it is incurred except where it meets the criteria for capitalisation. Where research and development expenditure is capitalised, it is amortised in accordance with the expected term of revenue streams. Amortisation does not commence until the income stream of the relevant project commences.

Patents

Where patent expenditure is capitalised, it is amortised in accordance with the expected term of the associated income streams. Amortisation does not commence until the income stream of the relevant project commences.

1.4 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Plant & machinery	-	15% straight line
Office equipment	-	25% straight line
Website development	-	20% straight line

1.5 Foreign currencies

Transactions in foreign currencies are translated into sterling at the rate ruling on the date of the transaction.

Exchange gains and losses are recognised in the profit and loss account.

1. ACCOUNTING POLICIES (continued)

1.6 Deferred taxation

Full provision is made for deferred tax assets and liabilities arising from all timing differences between the recognition of gains and losses in the financial statements and recognition in the tax computation.

A net deferred tax asset is recognised only if it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

Deferred tax assets and liabilities are calculated at the tax rates expected to be effective at the time the timing differences are expected to reverse.

Deferred tax assets and liabilities are not discounted.

1.7 Government grants

Government grants relating to capitalised research and development costs are treated as deferred income and released to the profit and loss account in accordance with the period of amortisation of those costs. Other grants are credited to the profit and loss account as the related expenditure is incurred.
