NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2017

1. General information

Future Inns (GB) Limited is a private limited company, limited by shares and incorporated in England and Wales and is registered at Hemingway Road, Cardiff, CF10 4AU.

2. Accounting policies

2.1 Basis of preparation of financial statements
