**ORDER**

---

**UPON** the application of the Applicants dated 28 October 2022 for an order under Rule 12.36 of the Insolvency (England and Wales) Rules 2016 (SI 2016/1024) (the "**Application**") (and the "**Rules**") to remove the First Applicant (the "**Outgoing Office-Holder**") from the insolvency offices held by him in the attached Schedules to this Order (together the "**Block Transfer Cases**") and to replace him as office-holder with the relevant Respondents as listed in the attached Schedules (the "**Replacement Office-Holders**")

**AND UPON** reading the evidence filed with the Application

**AND UPON** the Court being satisfied that it is appropriate to determine the Application on paper

**AND UPON** the Court being satisfied that the Outgoing Office-Holder is otherwise unable or

unwilling to continue in office and that it is expedient to transfer all of the Block Transfer Cases to the Replacement Office-Holders

**AND UPON** the Court being satisfied that the Replacement Office-Holders are qualified to act as insolvency practitioners in relation to a company or a bankrupt (as the case may be) and that they have consented to act in place of the Outgoing Officeholder

**AND UPON** notice of the Application having been given to the Secretary of State on 28 October 2022

**IT IS ORDERED THAT:**

**Temporary Transfer of Cases**

1. Each of the County Court cases listed in Schedule 1 of this Order be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List (ChD), pursuant to Rule 12.37(1)(a) of the Rules for the purpose only of considering and making this Order and shall be transferred back forthwith upon the making of this order without any intervening administrative action.

**Administrations**

2. With immediate effect the Outgoing Office-Holder is removed and the Relevant Office-Holders appointed as joint administrator of the companies listed in Schedule 2 of this Order.

### **Bankruptcies**

3. With immediate effect the Outgoing Office-Holder is removed and the Relevant Office-Holder appointed as trustee in bankruptcy of the individuals listed in Schedule 3 of this Order.

### **Creditors' Voluntary Liquidations**

4. With immediate effect the Outgoing Office-Holder is removed and the Relevant Office-Holder appointed as joint liquidator of the companies listed in Schedule 4 of this Order.

### **Members' Voluntary Liquidations**

5. With immediate effect the Outgoing Office-Holder is removed and the Relevant Office-Holder appointed as joint liquidator of the companies listed in Schedule 5 of this Order.

### **Notice**

6. The Applicants shall file a copy of this Order with each of the courts listed in Schedule 1 of this Order.
7. The creditors or, in the case of any members' voluntary liquidation, the members in each of the Block Transfer Cases be notified of this Order by advertisement in the London Gazette within 28 days from the date of this Order (the "**Advertisement**"). The creditors or members (as applicable) in each case shall be given further notice at the time of the next statutory reporting requirement for each case.
8. Any creditor or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in Schedules 2-5 of this Order who has an objection to this Order shall have 28 days from the date of the Advertisement to apply to court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the court.
9. In respect of the company matters appearing in Schedules 2, 4 and 5 of this Order, notification of the transfer shall be given to the Registrar of Companies within 28 days from the date of this Order.
10. Each Replacement Office-Holder shall give notice to the Secretary of State in respect of each of the Block Transfer Cases as soon as reasonably practicable.

### **Joint appointments**

11. Where any appointment made by this Order is on a joint basis, the powers of the office-holders pursuant to their appointment may be exercised by any one or more of them.

#### **Discharge and release**

12. In respect of his appointments as joint administrator the Outgoing Office-Holder shall receive his discharge under paragraph 98 of Schedule B1 to the Insolvency Act 1986 28 days after the Advertisement unless a creditor has made an application pursuant to paragraph 8 above to set aside or vary the terms of this Order in which event release in respect of any appointment the subject-matter of such application shall await further order of the Court.
13. Save as aforesaid the Outgoing Office-Holder shall be released on application to the Secretary of State.

#### **Costs**

14. No order as to costs.

#### **Secretary of State**

15. The Secretary of State do have permission to apply to vary or set aside this Order within 14 days of its service upon him.
